#### Section 21

#### ANIMAL HEALTH ACT 1995

Section 18

GENERAL AUTHORITY FOR THE IMPORTATION OF BEES AND BEE
PRODUCTS

I, RODERICK ANDREWARTHA, Chief Veterinary Officer, hereby issue a General Authority for the importation of Bees and Bee Products.

The following conditions apply:—

- Queen bees and escort bees may be imported provided that;
  - a. they are in new plastic queen cages; and
  - b. the escort bees have been hand caught; and
  - c. the bees were inspected at the time they were placed in the queen cages and found to be free of any evidence of Small Hive Beetle (Aethina tumida);
     and
  - d. the queen bee breeder has an active management program to control Small Hive Beetle.
- Substances produced or collected by bees, other than bees wax and honey, may be imported without restriction.
- Honey shall come from apiaries free of AFB and colonies (hives) not showing any clinical signs of diseases of hees
- 4. Bees wax must have been melted and cooled.
- The consignor of the bees or bee products in the exporting state or territory must certify that, to the best of their knowledge, all of the above conditions have been met.
- 6.All certification must be in a form approved by the Chief Veterinary Officer, and must be presented to an inspector when the animals arrive in Tasmania.

#### VEHICLE AND TRAFFIC (VEHICLE OPERATIONS) NOTICE 2010

Regulation 45(1)(a)

Notice of Exemption granted under Division 2 Part 6 of the Vehicle and Traffic (Vehicle Operations) Regulations 2001 to allow an additional temporary route for use of B-doubles and Truck and Dog Trailer Combinations.

IN ACCORDANCE with the provisions of Regulation 45(1) (a) of the *Vehicle and Traffic (Vehicle Operations) Regulations 2001*, the Transport Commission hereby gives notice that during the temporary night closures of the Bridgewater Bridge (to allow its refurbishment), a person using, or causing the use of a B-double or a Truck and Dog Trailer Combination is exempt from the provisions of the *Vehicle and Traffic (Vehicle Operations) Regulations 2001* as set out in paragraph 1 and 3 when using the route specified in paragraph 5, subject to the conditions specified in paragraphs 2 and 4 during any period specified in paragraph 6.

#### 1 Exemption for B-doubles

Subject to the conditions specified in paragraph 2(a) a person using, or causing or permitting the use of a B-double is exempted from regulations 13 and 22(7)(a) and (d) of the *Vehicle and Traffic (Vehicle Operations) Regulations 2001* for use on the route specified in paragraph 5 during any period specified in paragraph 6.

#### 2 Conditions on exemption for B-doubles

- (a) The B-double combination must comply with the same conditions of exemption for B-doubles as set out in clause 5 and 7 of Part 2 of the *Vehicle and Traffic* (*Vehicle Operations*) Notice 2009, with the exception of clauses 5(b)(ii) and 7(a).
- (b) The B-double combination must not exceed
  - (i) 26 metres in length, inclusive of its load and,
  - (ii) the aggregate axle load calculated in accordance with the allowable axle group of the combination, or 62.5 tonnes, whichever is the lesser.

(c) The B-double combination must not exceed a speed of 80 km/h.

#### 3 Exemption for Truck and Dog Trailer Combinations

Subject to the conditions specified in paragraph 4 a person using, or causing or permitting the use of a Truck and Dog Trailer Combination is exempted from regulations 13, 21 and 22(7)(a) and (d) of the *Vehicle and Traffic (Vehicle Operations) Regulations 2001* for use on the route specified in paragraph 5 during the period specified in paragraph 6.

## 4 Conditions on Exemption for Truck and Dog Trailer Combinations

- (a) The vehicle or combination must comply with the same conditions of exemption for Truck and Dog Trailer Combinations as set out in clause 9 of Part 3 of the *Vehicle and Traffic (Vehicle Operations) Notice 2009*, with the exception of clause 9(b)(ii).
- (b) The Truck and Dog Trailer combination must not exceed
  - (i) 25 metres in length, inclusive of its load and,
  - (ii) the aggregate axle load calculated in accordance with the allowable axle group of the combination, or 60.5 tonnes, whichever is the lesser.
- (c) The Truck and Dog Trailer combination must not exceed a speed of 80 km/h.

#### 5 Specified route for the exemption for B-doubles and Truck and Dog Trailer Combinations

Boyer Secondary Road (B10) between Boyer and Bridgewater.

# 6 Specified dates and period of time that applies to this exemption

During the time the Bridgewater Bridge is temporarily closed to traffic from 7pm Monday 27 September 2010 to 6am Sunday 5 December 2010 inclusive, it is planned to close the bridge for refurbishment

from 7pm Monday to 6am Tuesday

from 7pm Tuesday to 6am Wednesday

from 7pm Wednesday to 6am Thursday

from 7pm Thursday to 6am Friday

from 7pm Friday to 6am Saturday

from 7pm Saturday to 6am Sunday

There will be no night closures from 6am Sunday to 7pm Monday of each week during the period of closure.

Regulation 45(1)(a)

Notice of Exemption granted under Division 2 Part 6 of the Vehicle and Traffic (Vehicle Operations) Regulations 2001 to allow additional temporary routes for Higher Mass Limits for Vehicles and Combinations with Road-friendly Suspension.

IN ACCORDANCE with the provisions of Regulation 45(1) (a) of the *Vehicle and Traffic (Vehicle Operations) Regulations* 2001, the Transport Commission hereby gives notice that during the temporary night closures of the Bridgewater Bridge (to allow its refurbishment), a person using, or causing the use

# 2 Conditions on exemption for vehicles with road friendly suspension

- (a) The vehicle or combination must comply with the same conditions of exemption as set out for vehicles with road friendly suspension in clauses 10 and 11 of Part 4 of the *Vehicle and Traffic (Vehicle Operations) Notice* 2009, other than clause 11(a).
- (b) The same axle mass limits in clause 12 of Part 4 of the Vehicle and Traffic (Vehicle Operations) Notice 2009 apply to this exemption.

#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Proclamation under section 2 of the Integrity Commission Act 2009

This proclamation fixes 1 December 2010 as the day on which section 11 of the *Integrity Commission Act 2009* commences and fixes 1 October 2010 as the day on which the remaining provisions of that Act commence.

(2) Fisheries (General and Fees) Amendment Regulations 2010

These regulations amend the Fisheries (General and Fees) Regulations 2006 so as to -

- (a) extend the Perkins Bay greenlip area, being an area adjacent to the north coast of Tasmania in respect of which the minimum size limit for the shell length of greenlip abalone is 132 millimetres; and
- (b) allow the Minister to extend the duration of a management plan, once only, for a period not exceeding 12 months.
  - (3) Proclamation under section 2 of the Public Interest Disclosures Amendment Act 2009

This proclamation fixes 1 October 2010 as the day on which the Public Interest Disclosures Amendment Act 2009 commences.

(4) Proclamation under section 2(2) of the Public Sector Superannuation (Miscellaneous Amendments) Act 2009

This proclamation fixes 1 October 2010 as the day on which the provisions of Parts 2, 3, 4, 5, 8, 10, 12, 14, 15 and 16 of the *Public Sector Superannuation (Miscellaneous Amendments) Act 2009* commence.
