GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Community Protection (Offender Reporting) Amendment Regulations 2011*

These regulations amend the *Community Protection (Offender Reporting) Regulations 2006* by prescribing police officers working under the direction or control of the Registrar as authorised persons for the purposes of section 3 of the *Community Protection (Offender Reporting) Act 2005*.

(2) *Inland Fisheries (Recreational Fishing) Amendment Regulations 2011*

These regulations amend the *Inland Fisheries (Recreational Fishing) Regulations 2009* by –

- (a) updating certain provisions relating to the management of inland fisheries; and
- (b) effecting minor statute law revision.

(3) *Fisheries (Infringement Notices) Regulations 2011*

These regulations –

- (a) prescribe certain offences under the *Living Marine Resources Management Act 1995*, the *Fisheries (General and Fees) Regulations 2006* and the *Fisheries Rules 2009* as offences for which infringement notices may be issued; and
- (b) prescribe the penalties payable for those infringement notice offences; and
- (c) are made consequentially on the repeal of the *Fisheries (Infringement Notices) Regulations 2001* under section 11 of the *Subordinate Legislation Act 1992*.

(4) *Misuse of Drugs Order 2011*

This order amends the *Misuse of Drugs Act 2001* by adding certain substances to the lists of controlled drugs and controlled precursors.

(5) Proclamation under section 11(2) of the *Nature Conservation Act 2002*

This proclamation, under the *Nature Conservation Act 2002* –

- (a) declares certain areas of Crown land to be reserved land in the class of conservation area; and
- (b) in doing so, creates certain new conservation areas and extends certain existing conservation areas.

(6) Proclamation under section 11(2) of the *Nature Conservation Act 2002*

This proclamation, under the *Nature Conservation Act 2002* –

- (a) declares certain areas of Crown land to be reserved land in the class of conservation area; and
- (b) in doing so, creates certain new conservation areas and extends certain existing conservation areas.

(7) Proclamation under section 11(2) of the *Nature Conservation Act 2002*

This proclamation, under the *Nature Conservation Act 2002* –

- (a) declares certain areas of Crown land to be reserved land in the class of nature recreation area; and
- (b) in doing so, creates certain new nature recreation areas and extends certain existing nature recreation areas.

(8) Proclamation under the *Nature Conservation Act 2002* pursuant to section 12(2)(c)(i) of the *Port Arthur Historic Site Management Authority Act 1987*

This proclamation declares certain reserved land, known as the Cascades Female Factory Historic Site, to form part of the historic site under the *Port Arthur Historic Site Management Authority Act 1987*.

(9) *Racing (Bookmaker Betting) Amendment Regulations 2011*

These regulations amend the *Racing (Bookmaker Betting) Regulations 2004* by increasing the bet liability of on-course bookmakers to \$1 000 for all bets, except for bookmakers conducting bookmaking operations on King Island.
