In accordance with section 5 of the Fee Units Act, the value of a fee unit is increased by the CPI increase and for 2011-12 will be \$1.40.

In accordance with section 5(4) of the Fee Units Act, I have determined the fee unit adjustment factor for 2011-12 to be zero.

In determining the value of the fee unit adjustment factor, I am satisfied that there were no special factors that would warrant the discounting of the increase in the value of a fee unit in 2011-12 below the CPI increase.

The Guidelines set out the product and pricing information tobacco retailers may display, notices they must display, information they must provide to employees, and packaging and labelling requirements for manufacturers and distributors. It is an offence under the Act not to comply with the Guidelines.
