Amendment of Approved 'Pro-forma Fallback Contract' proposed by Aurora Energy Pty Ltd

AURORA ENERGY hereby publishes an amendment to the approved 'Pro-forma Fallback Contract' pursuant to sub-regulation 15(8) of the *Electricity Supply Industry (Contestable Customer) Regulations 2005*.

Amendment to Section 6(a)(i) of the Pro-forma Fallback Contract (>150 MWh per annum and ≤750 MWh per Annum) to replace consumption rate of 8.586 cents per kWh with 9.729 cents per kWh.

The amended 'Pro-forma Fallback Contract' takes effect from the date of publication in this *Gazette*.
