VEHICLE AND TRAFFIC (VEHICLE OPERATIONS) NOTICE 2011

Regulation 45(1)(a)

NOTICE of Exemption granted under Division 2 Part 6 of the *Vehicle and Traffic (Vehicle Operations) Regulations 2001* to allow a temporary alternative route for use of B-doubles, Truck and Dog Trailer Combinations and vehicles with road friendly suspension.

In accordance with the provisions of Regulation 45(1)(a) of the *Vehicle and Traffic (Vehicle Operations) Regulations 2001*, the Transport Commission hereby gives notice that during the temporary partial closure of the Birrale Road/Bass Highway West bound access ramp (to allow its refurbishment), a person using, or causing the use of a B-double or a Truck and Dog Trailer Combination or a vehicle with road friendly suspension is exempt from the provisions of the *Vehicle and Traffic (Vehicle Operations) Regulations 2001* as set out in paragraphs 1, 3 and 5 when using the route specified in paragraph 7, subject to the conditions specified in paragraphs 2, 4 and 6 during the period specified in paragraph 8.

1 Exemption for B-doubles

Subject to the conditions specified in paragraph 2 a person using, or causing or permitting the use of a B-double on the route specified in paragraph 7 is exempted from regulations 13 and 22(7)(a) and (d) of the *Vehicle and Traffic (Vehicle Operations) Regulations 2001* during the period specified in paragraph 8.

2 Conditions on exemption for B-doubles

(a) The B-double combination must comply with the same conditions of exemption for B-doubles as set out in clause 5 and 7 of Part 2 of the *Vehicle and Traffic (Vehicle Operations) Notice 2010*, with the exception of clause 7(a).

(b) The B-double combination must not exceed

- (i) 26 metres in length, inclusive of its load and,
- (ii) the aggregate axle load calculated in accordance with the allowable axle group of the combination, or 62.5 tonnes, whichever is the lesser.

3 Exemption for Truck and Dog Trailer Combinations

Subject to the conditions specified in paragraph 4 a person using, or causing or permitting the use of a Truck and Dog Trailer Combination on the route specified in paragraph 7 is exempted from regulations 13, 21 and 22(7)(a) and (d) of the *Vehicle and Traffic (Vehicle Operations) Regulations 2001* during the period specified in paragraph 8.

4 Conditions on Exemption for Truck and Dog Trailer Combinations

(a) The vehicle or combination must comply with the same conditions of exemption for Truck and Dog Trailer Combinations as set out in clause 9 of Part 3 of the *Vehicle and Traffic (Vehicle Operations) Notice 2010*.

(b) The Truck and Dog Trailer combination must not exceed

- (i) 25 metres in length, inclusive of its load and,
- (ii) the aggregate axle load calculated in accordance with the allowable axle group of the combination, or 60.5 tonnes, whichever is the lesser.

5 Exemption for vehicles with road friendly suspension

Subject to the conditions specified in paragraph 6 a person using, or causing the use of vehicles and combinations with road-friendly suspension on the route specified in paragraph 7 is exempt from regulations 22(3)(e)(ii), 22(4)(d)(ii), 22(7)(a) and (d) of the *Vehicle and Traffic (Vehicle Operations) Regulations 2001* during the period specified in paragraph 8.

6 Conditions on exemption for vehicles with road friendly suspension

(a) The vehicle or combination must comply with the same conditions of exemption as set out for vehicles with road friendly suspension in clauses 10 and 11 of Part 4 of the *Vehicle and Traffic (Vehicle Operations) Notice 2010*, other than clause 11(a).

(b) The same axle mass limits in clause 12 of Part 4 of the *Vehicle and Traffic (Vehicle Operations) Notice 2010* apply to this exemption.

7 Specified route for the exemption for B-doubles, Truck and Dog Trailer Combinations and vehicles fitted with road friendly suspension

(a) The section of William Street Westbury between the Bass Highway and Meander Valley Secondary Road and

(b) The approximately 4.9 km section of Meander Valley Secondary Road west of the junction with William Street Westbury to the Violet Banks Bass Highway access ramp.

I, KIM CREAK, the Delegate of the Designated Authority in respect of the offshore area of Tasmania for and on behalf of the Commonwealth – Tasmania Offshore Petroleum Joint Authority, in pursuance of section 104 of the *Offshore Petroleum and Greenhouse Gas Storage Act 2006* (the Act) of the Commonwealth of Australia, hereby invite applications for the grant of a petroleum exploration permit in respect of the following blocks within the area as described in the following schedule.

Applications for area T11-1 must be received, in the manner prescribed below, by 4:00pm (Eastern Standard Time) on **Thursday 13 October 2011**.

APPLICATIONS

Applications for the exploration permit in relation to the above area must be made in an approved manner and be accompanied by details of:

a. the applicant's proposals for work and expenditure in relation to the block or blocks specified in the application;

Applicants should propose an exploration strategy that has the potential to significantly advance the assessment and understanding of the petroleum potential of the permit area.

The exploration strategy should be supported by a technical assessment of the release area and the detailed descriptions of the work activities proposed for each year in the six

(6) year permit term. It is expected that both the primary and secondary work programs will contain substantial new operational activities commensurate with the assessed petroleum prospectivity and understanding of the area. Expenditure should be categorised against each element of the work program and stated in Australian dollars.

In developing work programs applicants must take account of any Notices or Special Notices in relation to the area as listed in the annual Commonwealth Offshore Petroleum Exploration Acreage Release information package, which is available at www.petroleum-acreage.gov.au, along with ability to comply with the requirements of the Act, its Regulations and any Directions issued under the Act, and with any special conditions associated with each area. As well as the relevant provisions of the *Environmental Protection and Biodiversity Conservation Act 1999*, its Regulations and associated directions and documents when proposing petroleum operations.

b. the technical qualifications of the applicant and of the applicant's employees and / or the technical advice available to the applicant;

Details of the technical qualifications of the applicant and its key employees and/or details of the technical advice available to the applicant (by way of consultants or other providers) that will enable it to meet its work program commitments.

c. the financial resources available to the applicant.

The financial resources available to the applicant, including evidence of the applicant's ability to fund the proposed work program, a statement of other exploration commitments over the next six years, and a copy of the latest annual and quarterly reports for each applicant company.

FEE

Applications must be accompanied by a fee payable to the "Commonwealth of Australia" through an Australian bank or bank cheque. The amount of the fee is prescribed in Regulations under the Act, and at the time of printing was \$A4,590, which is GST free.
