PUBLIC NOTICE – TOTAL ALLOWABLE CATCH – MAXIMUM LIVE WEIGHT TAKE FOR CONTROLLED FISH FOR THE COMMERCIAL DIVE FISHERY

DEFINITION OF THE PARTS OF THE COMMERCIAL DIVE FISHERY AND THE PORTION OF THE MAXIMUM LIVE WEIGHT OF A CONTROLLED FISH THAT CAN BE TAKEN FROM THE PARTS OF THE COMMERCIAL DIVE FISHERY

I, ROBERT GOTT, Director (Marine Resources), acting pursuant to Rule 14 of the *Fisheries (Commercial Dive Rules) 2011* and delegated authority under Section 20(1) of the *Living Marine Resources Management Act 1995* hereby determine:

that the maximum live weight of *Heliocidaris erythrogramma* which may be taken in the period from 1 September in any year

to 31 August in the following year from the Commercial Dive Fishery is 166 tonnes; and,

that the parts of the Commercial Dive Fishery from which the maximum live weight of *Heliocidaris erythrogramma* may be taken are:

- I. **Central Eastern Sea Urchin Part of the Fishery** being that area of State waters generally off the East coast of Tasmania bounded in the north by the line of latitude 42° 03' 25" S and in the south and east by an imaginary line starting where longitude 148° 00' 00" E intersects with the high water mark on the southern tip of Cape Pillar, then running due south to the outer limit of State waters, then following the limit of State waters in an anticlockwise direction to the line of latitude 42° 03' 25" S;
- II. **South Eastern Sea Urchin Part of the Fishery** being that area of State waters generally off the southern coast of Tasmania, including those waters in Blackmans Bay, Norfolk Bay, Frederick Henry Bay, the River Derwent and the D'Entrecasteaux Channel, bounded in the east by the line of longitude 148° 00' 00" E and in the west by the line of longitude 146° 52' 15" E;
- III. **Undeveloped Sea Urchin Part of the Fishery** being that area of State waters bounded by an imaginary line starting from where the line of longitude 146° 52' 15" E intersects with the high water mark on the Tasmanian mainland at Whale Head, then running due south to the limit of State waters, then running in a clockwise direction around that limit of State waters to the line of latitude 42° 03' 25" S off the east coast of Tasmania, then running due west to the high water mark on the east coast of the mainland of Tasmania;

that the maximum live weight of *Heliocidaris erythrogramma* which may be taken from each part of the Commercial Dive Fishery is:

- I. Central Eastern Sea Urchin Part of the Fishery – 39 tonnes;
- II. South Eastern Sea Urchin Part of the Fishery – 44 tonnes;
- III. Undeveloped Sea Urchin Part of the Fishery – 83 tonnes;

that the maximum live weight of periwinkles (molluscs of the *Genus Turbo*) which may be taken in the period from 1 September in any year to 31 August in the following year from the Commercial Dive Fishery is 35.2 tonnes; and,

that the parts of the Commercial Dive Fishery from which the maximum live weight of Periwinkles may be taken are:

- I. **Central Eastern Periwinkles Part of the Fishery** being that area of State waters generally off the east coast of Tasmania bounded in the north by the line of latitude 42° 03' 25" S and in the south and east by an imaginary line starting where longitude 148° 00' 00" E intersects with the high water mark on the southern tip of Cape Pillar, then running due south to the outer limit of State waters, then following the limit of State waters in an anticlockwise direction to the line of latitude 42° 03' 25" S;
- II. **South Eastern Periwinkles Part of the Fishery** being that area of State waters generally off the southern coast of Tasmania, including those waters in Blackmans Bay, Norfolk Bay, Frederick Henry Bay, the River Derwent

and the D'Entrecasteaux Channel, bounded in the east by the line of longitude 148° 00' 00" E and in the west by the line of longitude 146° 52' 15" E;

- III. **Undeveloped Periwinkles Part of the Fishery** being that area of State waters bounded by an imaginary line starting from where the line of longitude 146° 52' 15" E intersects with the high water mark on the Tasmanian mainland at Whale Head, then running due south to the limit of State waters, then running in a clockwise direction around that limit of State waters to the line of latitude 42° 03' 25" S off the east coast of Tasmania, then running due west to the high water mark on the east coast of the mainland of Tasmania;

that the maximum live weight of Periwinkles which may be taken from each part of the Commercial Dive Fishery is:

- I. Central Eastern Periwinkles Part of the Fishery and South Eastern Periwinkles Part of the Fishery combined - 17.6 tonnes; and,
II. Undeveloped Periwinkles Part of the Fishery - 17.6 tonnes.

where the size of molluscs of the *Genus Turbo* is measured as the maximum shell width of an individual mollusc.

- v. latitude 42o 27.7880 S, longitude 148o 4.7805 E; to
- vi. latitude 42o 31.9086 S, longitude 148o 4.7805 E; to
