GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Fisheries (Penalties) Regulations 2011*

These regulations –

- (a) specify the quantum of Grade 1 penalties, Grade 2 penalties and Grade 3 penalties for offences against regulations and rules under the *Living Marine Resources Management Act 1995* providing for such penalties; and
- (b) are made consequentially on the repeal of the *Fisheries Penalties Regulations 2001* under section 11 of the *Subordinate Legislation Act 1992*.

(2) *Fisheries (General and Fees) Amendment Regulations 2011*

These regulations amend the *Fisheries (General and Fees) Regulations 2006* by updating the definition of “Penalty Regulations” consequent on the making of the *Fisheries (Penalties) Regulations 2011*.
