#### NOTICE OF THE MAKING OF STATUTORY RULES

#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Vehicle and Traffic (Driver Licensing and Vehicle Registration) Amendment (Registration Labels) Regulations 2012*

These regulations amend the *Vehicle and Traffic (Driver Licensing and Vehicle Registration) Regulations 2010* by removing the requirement for registration labels to be issued in respect of certain vehicles.

(2) *Traffic (Compliance and Enforcement) Amendment Regulations 2012*

These regulations amend the *Traffic (Compliance and Enforcement) Regulations 2011* –

- (a) to reflect minor changes in certain offences consequent on the commencement of the *Vehicle and Traffic (Driver Licensing and Vehicle Registration) Amendment (Registration Labels) Regulations 2012*; and
- (b) by updating a legislative reference and effecting minor statute law revision.
