GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Allport Library and Museum of Fine Arts Regulations 2012

These regulations -

(a) provide for the use of the Allport Library and Museum of Fine Arts; and

(b) are made consequentially on the repeal of the *Allport Library and Museum of Fine Arts Regulations* 2002 under section 11 of the *Subordinate Legislation Act 1992*.

(2) Libraries Regulations 2012

These regulations -

- (a) provide for the use of the property and services of the State Library Service; and
- (b) are made consequentially on the repeal of the *Libraries Regulations 2002* under section 11 of the *Subordinate Legislation Act 1992*.

(3) Proclamation under section 11(2) of the Nature Conservation Act 2002

This proclamation, made under the Nature Conservation Act 2002 -

- (a) declares certain areas of Crown land to be reserved land in the class of conservation area; and
- (b) in doing so, creates and names certain new conservation areas.

(4) Proclamation under section 2 of the *Rail Safety National Law (Tasmania) Act 2012*

This proclamation fixes 20 January 2013 as the day on which the Rail Safety National Law (Tasmania) Act 2012 commences.

(5) Retirement Benefits (Parliamentary Superannuation) Regulations 2012

These regulations -

- (a) provide for the continuation of the Parliamentary Superannuation Fund established under the Parliamentary Superannuation Act 1973 and the Parliamentary Retiring Benefits Fund established under the Parliamentary Retiring Benefits Act 1985; and
- (b) provide for the preservation of entitlements to pensions and other benefits under those Acts; and
- (c) are made consequentially on the repeal of the *Retirement Benefits (Parliamentary Superannuation) Regulations* 2002 under section 11 of the *Subordinate Legislation Act 1992*.

(6) Proclamation under section 2 of the Veterinary Surgeous Amendment Act 2011

This proclamation fixes 12 December 2012 as the day on which the Veterinary Surgeons Amendment Act 2011 commences.

(7) Veterinary Surgeons Regulations 2012

These regulations, for the purposes of the Veterinary Surgeons Act 1987-

- (a) specify certain matters relating to registration under that Act; and
- (b) specify certain services that are not veterinary services under that Act; and
- (c) rescind the Veterinary Surgeons Regulations 2004.

(8) Work Health and Safety Regulations 2012

These regulations form part of a system of nationally harmonised work health and safety laws. They make provision in relation to the following:

- (a) health and safety representatives;
- (b) managing risks to health and safety;
- (c) general workplace management;
- (d) hazardous work;
- (e) plant and structures;
- (f) construction work;
- (g) hazardous chemicals;
- (h) asbestos;
- (i) major hazard facilities.

(9) Magistrates Court (Children's Division) Rules 2012

These rules of court regulate the proceedings of the Magistrates Court (Children's Division) under the *Children, Young Persons and Their Families Act 1997* and the *Magistrates Court (Children's Division) Act 1998*.
