TASMANIAN ELECTRICITY CODE

The amendment takes effect on 1 January 2013.

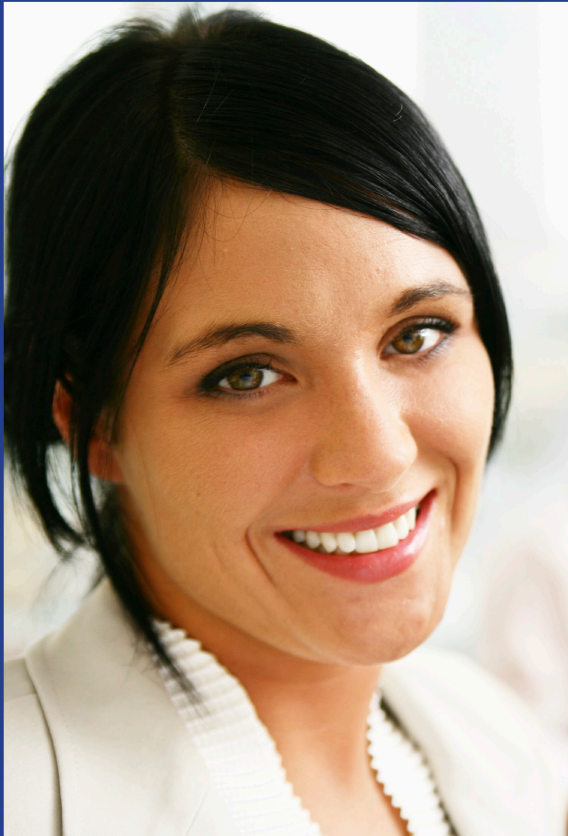
