- clarifying who is and is not covered by the portable long service scheme;
- adding to and amending existing definitions to make the Act easier to interpret and apply; and

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) General Fire Amendment Regulations 2012

These regulations amend the *General Fire Regulations 2010* by providing that certain education and care service premises, within the meaning of the Education and Care Services National Law (Tasmania), are specified buildings.

(2) Legal Profession Amendment Regulations 2012

These regulations amend the *Legal Profession Regulations 2008* by prescribing an amount of \$5.5 million for the purposes of section 361 of the *Legal Profession Act 2007*.

(3) Proclamation under section 2 of the Motor Vehicle Traders Act 2011

This proclamation-

- (a) fixes 1 March 2012 as the day on which the *Motor Vehicle Traders Act 2011*, other than sections 6 and 64 and Schedules 1 and 1A, commences; and
- (b) fixes 1 April 2012 as the day on which sections 6 and 64(2) of, and Schedule 1A to, that Act commence.

Section 64(1) of, and Schedule 1 to, the Motor Vehicle Traders Act 2011 commenced on 31 December 2011.

(4) Motor Vehicle Traders Regulations 2012

These regulations-

- (a) prescribe the fees payable under the Motor Vehicle Traders Act 2011; and
- (b) prescribe the form and content of a pre-sale disclosure statement; and
- (c) exempt certain persons and vehicles from the operation of that Act.
