GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Agricultural and Veterinary Chemicals (Control of Use) Regulations 2012*

These regulations –

- (a) prescribe the requirements in relation to –
 - (i) certain chemical products, including special precautions required for the handling and storing of certain poisons; and
 - (ii) hormonal growth promotants; and
- (b) prescribe certain fees payable under the *Agricultural and Veterinary Chemicals (Control of Use) Act 1995*; and
- (c) are made consequentially on the repeal of the *Agricultural and Veterinary Chemicals (Control of Use) Regulations 1996* under section 11 of *Subordinate Legislation Act 1992*.

(2) Proclamation under section 11(2) of the *Nature Conservation Act 2002*

This proclamation extends the Gordons Hill Nature Recreation Area.

(3) Proclamation under section 11(2) of the *Nature Conservation Act 2002*

This proclamation extends the Little Pine Lagoon, Mount Rummy and Southwest Conservation Areas.

(4) *Relationships Amendment Regulations 2012*

These regulations amend the *Relationships Regulations 2003* by –

- (a) providing an additional corresponding law and class of relationships for the purposes of section 65A of the *Relationships Act 2003*; and
- (b) effecting minor statute law revision.

(5) Proclamation under section 7 of the *Roads and Jetties Act 1935*

This proclamation, for the purposes of the Tarkine Road Project –

- (a) revokes 4 related proclamations made under the *Roads and Jetties Act 1935*; and
- (b) declares certain portions of certain forest roads in the north-west of the State to be subsidiary roads and classifies them as tourist roads.

(6) *Second-hand Dealers and Pawnbrokers (Exemption) Order 2012*

This order exempts licensed motor vehicle traders, within the meaning of the *Motor Vehicle Traders Act 2011*, from the operation of the *Second-hand Dealers and Pawnbrokers Act 1994*.
