IN REGULATED SYSTEMS

I, DR ROSCOE TAYLOR, Director of Public Health, hereby notify that on 23 April 2012, I issued the above guidelines under the *Public Health Act 1997*. The guidelines apply to owners of premises where warm water systems and cooling towers are installed and to persons engaged to operate them. The guidelines regulate the maintenance and operation of these systems so as to reduce public health risks relating to Legionella.

## Weed Management

### WEED MANAGEMENT ACT 1999

PUBLIC COMMENT ON STATUTORY WEED MANAGEMENT PLANS  
UNDER THE *WEED MANAGEMENT ACT 1999*

THE Department of Primary Industries, Parks, Water and Environment (DPIPWE) as part of declaration processes under the *Weed Management Act 1999* has developed statutory weed management plans for four *Nassella* species - Mexican feather grass (*Nassella tenuissima*), Texas needle grass (*Nassella leucotricha*), lobed needle grass (*Nassella charruana*) and cane needle grass (*Nassella hyalina*). Section 15(1) of the *Act* requires that statutory weed management plans be prepared for each declared weed species within 12 months of an order made under section 9 of the *Act* relating to those weeds.

These plans contain measures designed to reduce the impact of weeds on Tasmania's environmental, economic and social values. These measures include: information on the distribution and extent of the declared weed; actions to prevent weed introduction and spread; and management obligations for land owners under the *Act*.

Copies of the statutory weed management plans will be exhibited by DPIPWE for a period of 30 days from the date of this notice. They can be obtained at no cost by contacting DPIPWE on 1300 368 550, or from the DPIPWE website (www.dpipwe.tas.gov.au/weeds).

This order amends the *Poisons List Order 2001* by incorporating changes recommended by the National Drugs and Poisons Schedule Committee in the Standard for the Uniform Scheduling of Medicines and Poisons No. 2, Amendment No. 4.

(2) *Nature Conservation (Open Seasons) Amendment Order 2012*

This order amends the *Nature Conservation (Open Seasons) Order 2004* by —

- (a) removing the provisions relating to an open season for wild duck on King Island, with the result that the open season for wild duck on King Island is the same as the open season, prescribed in the order, for wild duck elsewhere in Tasmania; and
- (b) effecting minor statute law revision.
