PROBLEMS WITH HOMEMADE WILLS

Public Trustee

Your Will sets out your wishes for providing for your loved ones and how your affairs are to be managed after you are gone. Preparing your own Will or using a 'Do It Yourself' Will kit is not advisable because a Will must conform to strict legal requirements or the Courts may decide it is not valid. If this is the case, your assets will be distributed according to a predetermined formula which may not be as you intended. Sometimes having a homemade Will can be worse than not having a Will at all.

Some of the common problems with homemade Wills include:

- Failure to date the Will
- Failure to appoint an Executor
- Not allowing for a situation where a beneficiary dies before you
- Failure to sign and witness the Will in accordance with legal requirements
- Attempt to gift assets which are not owned solely by you
- Failure to dispose of all assets
- Use of ambiguous words (different legal meaning to ordinary meaning)



Why use a professional to prepare your Will?

Unnecessary costs and delays in administration may result from the problems and consequences associated with homemade Wills.

It is easier and cheaper to ensure that your Will is correct while you are alive than for your Executor to try to fix it after you die. The small amount you may save in professional fees is a false economy when compared to the potential consequences for your loved ones and your estate.
