GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Proclamation under section 2(2) of the Vehicle and Traffic Amendment (Heavy Vehicle Charges) Act 2012

This proclamation fixes 1 December 2012 as the day on which section 4 of the *Vehicle and Traffic Amendment* (Heavy Vehicle Charges) Act 2012 commences.

(2) Vehicle and Traffic (Offence Detection Devices) Regulations 2012

These regulations -

- (a) provide for the use of devices in the detection of traffic offences; and
- (b) are made consequentially on the repeal of the *Vehicle and Traffic (Offence Detection Devices) Regulations* 2002 under section 11 of the *Subordinate Legislation Act* 1992.
