This proclamation fixes 1 May 2013 as the day on which the provisions of the *Residential Tenancy Amendment (Smoke Alarms) Act 2012* commence.

##### (3) *Shop Trading Hours Order 2013*

This order declares that certain shops may be kept open before 12:30 p.m. on Anzac Day 2013.
