GREETING:

WHEREAS Members of the Tasmanian Parliament receive a basic salary and certain allowances and benefits as provided for by the *Parliamentary Salaries, Superannuation and Allowances Act 2012*

AND WHEREAS Clause 4 of Part 1 of Schedule 1 to the *Parliamentary Salaries, Superannuation and Allowances Act 2012* requires that before 1 July 2013 the Premier is to request the Commission, or a tribunal established by order-in-council for the purpose, to prepare a report determining the basic salary and other matters

AND WHEREAS the Premier has determined that a tribunal should be established to prepare a report to determine the basic salary and the matters specified in the terms of reference hereinafter set forth

AND WHEREAS it is now expedient to cause such a tribunal to be established to prepare such a report as soon as practicable, but before 31 May 2014

NOW I, THE HONOURABLE PETER GEORGE UNDERWOOD, Companion of the Order of Australia, Governor in and over the State of Tasmania and its Dependencies in the Commonwealth of Australia in exercise of the prerogative powers conferred upon me and acting on the advice of the Executive Council, do by this Order-in-Council, appoint the said TIMOTHY JOHN ABEY (who shall chair the tribunal), NICOLE MARY WELLS and BARBARA DEEGAN to be a tribunal with the following terms of reference:

With the objective of determining

- the basic salary for Members of the Tasmanian Parliament as required by clause 4 of Part 1 of Schedule 1 to the *Parliamentary Salaries, Superannuation and Allowances Act 2012*; and
- whether the entitlements of, and benefits provided to, Members of the Tasmanian Parliament (other than the basic salary, additional salary, or superannuation) provided for in Schedule 2 of the *Parliamentary Salaries, Superannuation and Allowances Act 2012* remain appropriate to the contemporary needs of such Members;

and taking account of the Government's wages policy;

by 31 May 2014, prepare and provide to the Premier a report determining:

- 1 the basic salary; and
- 2 any changes to any of the allowances and benefits provided for in Schedule 2 to the *Parliamentary Salaries, Superannuation and Allowances Act 2012*; and
