This proclamation fixes 28 August 2013 as the day on which the remaining provision of the *National Energy Retail Law (Tasmania) (Consequential Amendments) Act 2012* commences.

(4) *Vehicle and Traffic (Driver Licensing and Vehicle Registration) Amendment (Concession Eligibility) Regulations 2013*

These regulations amend the *Vehicle and Traffic (Driver Licensing and Vehicle Registration) Regulations 2010* to afford an eligible asylum seeker the same rebates and concessions as a pensioner under those regulations.
