#### PUBLIC NOTICE - DATES OF OPENING OF PART OF THE ROCK LOBSTER FISHERY

#### Rule 11 of the Fisheries (Rock Lobster) Rules 2011

I, Robert Gott, Director (Marine Resources), pursuant to my delegated power under section 20 (1) of the *Living Marine Resources Management Act 1995*, in accordance with Rule 11 (2) of the *Fisheries (Rock Lobster) Rules 2011*, hereby determine that:

- (1) the part of the commercial rock lobster fishery comprising of activities by way of setting rock lobster pots and taking male and female rock lobster for commercial purposes in eastern waters will be open from 07:00am (AEST) 9 February 2013; and,
- (2) the part of the non-commercial rock lobster fishery comprising of the taking of male and female rock lobster for non-commercial purposes and recreational purposes in eastern waters will be open from 07:00am (AEST) 9 February 2013; and,
- (3) the part of the non-commercial rock lobster fishery comprising of activities by way of setting rock lobster pots, setting rock lobster rings and diving for taking rock lobster for non-commercial and recreational purposes in eastern waters will be open from 07:00am (AEST) 9 February 2013;

where:

**"eastern waters"** is defined to mean State waters adjacent to the east coast of Tasmania bounded in the south on the east coast by the line of latitude at  $42^{\circ} 49' 00$ " South, and bounded in the north on the east coast by the line of latitude at  $41^{\circ} 16' 17$ " South.

Words and expressions used in this public notice have the same meaning as in the *Living Marine Resources Management Act 1995* and the *Fisheries (Rock Lobster) Rules 2011.*

### Rule 9 of the Fisheries (Giant Crab) Rules 2006

I, Wes Ford, General Manager (Water and Marine Resources), pursuant to my delegated power under section 20 (1) of the *Living Marine Resources Management Act 1995*, in accordance with Rule 9 (b) of the *Fisheries (Giant Crab) Rules 2006*, hereby determine that:

(1) the part of the commercial giant crab fishery comprising of activities by way of setting giant crab traps and taking male and female giant crab for commercial purposes in eastern waters will be open from 13 February 2013.

## Where:

**"eastern waters"** is defined to mean the area of State waters adjacent to the east coast of Tasmania bounded in the north on the east coast by the line of latitude at  $41^{\circ}$  16'17" South and bounded in the south on the east coast by the line of latitude at  $42^{\circ}$  49' 00" South.

Words and expressions used in this public notice have the same meaning as in the *Living Marine Resources Management Act* 1995 and the *Fisheries (Giant Crab) Rules 2006.*
