- (d) the Dominant Owner must indemnify the Land Owner against all loss the Land Owner suffers as a result of any claim against the Land Owner in connection with loss of life, personal injury or damage to property that is caused or contributed to in the course of exercising those rights except to the extent that the loss, damage or injury is caused by the negligence, wilful act, default or omission of the Land Owner.

#### 5. Interpretation

In this Schedule 2, unless the context otherwise requires:

- (a) "the Dominant Owner" means the registered proprietor of Lot 5 and Lot 6 on Plan of Survey P 16521 0 in the Office of the Recorder of Titles or any part of it;
- (b) the singular includes the plural and vice versa;
- (c) a reference to an individual or person includes a corporation, partnership, joint venture, association, authority, trust, state or government and vice versa;
- (d) a reference to any gender includes all genders;
- (e) a reference to any agreement or document is to that agreement or document (and, where applicable, any of its provisions) as amended, notated, supplemented or replaced from time to time;
- (f) a reference to any party to an easement, or any other document or arrangement, includes that party's executors, administrators, substitutes, successors and permitted assigns;
- (g) where an expression is defined, another part of speech or grammatical form of that expression has a corresponding meaning; and
- (h) headings are for convenience of reference only and do not affect interpretation.
