Total reported carbon dioxide equivalent emissions for Tasmania in the baseline year ending 30 June 1990 were 11.28 megatonnes. Reported carbon dioxide equivalent emissions for the year ending June 30 2011 totalled 7.46 megatonnes. This represents an overall reduction in net emissions of approximately 3.83 megatonnes or 34 per cent from 1989-90 levels.

A draft Aboriginal Heritage Protection Bill was the subject of public consultation in late 2012. Draft Regulations and an accompanying regulatory impact statement have now been released for comment.

The proposed Regulations will support the operation of the new legislative framework, including by setting values for some Management Plan triggers and for exemptions.

In accordance with the *Subordinate Legislation Act 1992*, a regulatory impact statement has been prepared to explain the likely impact of the draft regulations.

The Tasmanian Government invites written submissions on the proposed *Aboriginal Heritage Protection Regulations 2013*.

Division 2 – Plumbing Standards

NOTICE OF MAKING OF REVISED TASMANIAN PLUMBING CODE

NOTICE is given to building and plumbing practitioners and the public that the Minister for Workplace Relations issued the *Tasmanian Plumbing Code 2013* on 15 May 2013. The Code was first issued in November 1994 and previously revised in 2006. The 2013 Code replaces the 2006 Code and is to be adopted by the State on the 1 July 2013.

Changes to the 2013 Code include:

- Alignment with the National Construction Code.
- Inclusion of explanatory information.
- Reference to later versions of Australian Standards adopted for on-site waste water management systems.
- Revised trade waste appliance diagrams and installation notes for systems installed in areas not serviced by a water and sewerage authority.
- New provisions for cold water storage tanks used for the collection, storage and supply of water. The provisions include manufacturing requirements such as the materials to be used in their manufacture, tank warranty and signage on tanks.
- Where an on-site waste water management system is installed in areas not serviced by the water and sewerage authority, the system is to be connected to the sewer.
- The removal of a number of prior variations to the Plumbing Code of Australia.
