#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

#### (1) Firearms Act 1996

These regulations amend the *Firearms Regulations 2006* by providing that seal control caps, at times referred to as scare darts, are ammunition within the meaning of the *Firearms Act 1996* with the result that they are subject to certain prohibitions and restrictions under that Act.

(2) Proclamation under section 11(2) of the Nautre Conservation Act 2002

This proclamation, under the Nautre Conservation Act 2002 -

- (a) declares certain areas of Crown land to be reserved land in the class of conservation area; and
- (b) in doing so, creates certain new conservation areas.
