#### ANIMAL HEALTH ACT 1995

#### Section 42

#### **Declaration of a Protected Area**

I, RODERICK ANDREWARTHA, Chief Veterinary Officer, acting pursuant to section 42 of the *Animal Health Act 1995* (the Act) hereby declare the municipal area defined as Flinders CPR 2978 in Column 1 of Schedule 3 of the Local Government Act 1993, to be a Protected Area for the purpose of preventing the introduction into the area of the disease paratuberculosis (Johne's disease) of cattle.

Pursuant to section 43 of the Act, I declare that no cattle, goats, deer, camels or South American camelids may be moved into the protected area unless they comply with conditions specified in Schedule 1.

#### Schedule 1

#### Cattle

No cattle may be moved into the protected area other than cattle moved from either—

- a) a Bovine Johne's disease Protected Zone or Free Zone;
   or
- b) a Beef Only herd, Cattle MAP MN1 herd or herd of higher status or Dairy score 8 or higher-

as defined under the National Johne's Disease Program – BJD Standard Definitions, Rules and Guidelines for the control of Cattle Strains of Mycobacterium paratuberculosis in cattle and for goats, deer and camelids applying at the time of import.

#### Goats

No goats may be moved into the protected area other than goats that are moved from;

- a) a Bovine Johne's Disease (BJD) Protected or Free Zone;
- b) a Beef Protected Area and the herd of origin meets the following criteria:
  - i) Dairy goats or non-dairy goats with risk factors must have a Goat Assurance Score of 6 or higher; or
  - ii) Non-dairy goats with no risk factors must have a Goat Assurance Score of 5 or higher; or
- a) a BJD Management Area and the herd meets the following criteria:
  - i) Dairy goats must have a Goat Assurance Score of 8 or higher; or
  - ii) Non-dairy goats must have a Goat Assurance Score of 7 or higher -

as defined in the National Johne's Disease Program – BJD Standard Definitions Rules and Guidelines for the control of Cattle Strains of Mycobacterium paratuberculosis in cattle and for goats, deer and camelids applying at the time of import.

#### Camels and South American Camelids (Alpaca, llamas etc)

No camels or South American camelids (Alpaca, llamas etc) may be moved into the protected area other than camels or South American camelids moved from either—

- a) a Bovine Johne's Disease Protected Zone or Free Zone;
   or
- b) an Alpaca MAP MN1 herd (or equivalent) or herd of higher status –

as defined under the National Johne's Disease Program – BJD Standard Definitions Rules and Guidelines for the control of Cattle Strains of Mycobacterium paratuberculosis in cattle and for goats, deer and camelids applying at the time of import.

#### Deer

No deer may be moved into the protected area without a permit issued under section 44 of the Act.

#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Inland Fisheries (Seasons and Waters) Amendment Order 2013

This order amends the Inland Fisheries (Seasons and Waters) Order 1996 by -

- (a) opening Lake King William to the taking of acclimatised fish all year round; and
- (b) prohibiting the taking of fish at all times at the dam wall and associated infrastructure at Craigbourne Dam.
