## Occupational Licensing

### OCCUPATIONAL LICENSING ACT 2005

I, DALE EDWARD WEBSTER, Administrator of Occupational Licensing, make the following Order under section 99 of the *Occupational Licensing Act 2005*.

#### 1. Short title

This Order may be cited as the *Occupational Licensing (Inspection of Sewer and Stormwater Plumbing and Drainage Pipes Exemption) Order 2013*.

#### 2. Commencement

This Order takes effect on 6 November 2013.

#### 3. Purpose of the Order

The purpose of the Order is to exempt persons who specialise in carrying out inspection of sewer or stormwater plumbing and drainage pipes using closed circuit television (CCTV) cameras from the provisions of the Act, under certain conditions.

#### 4. Interpretation

In this Order, unless the context otherwise requires –

“Act” means the *Occupational Licensing Act 2005*;

“CCTV camera” means a closed circuit television camera which produces images or recordings for inspection purposes;

“Determination” means the *Occupational Licensing (Plumbing Work) Determination 2013*;

“Plumber Practitioner (Drainage)” is the licence referred to in Clause 4.1(c) of the Determination;

“Plumber Practitioner (Certifier) – Drainage” is the licence referred to in Clause 4.3(c) of the Determination.

#### 5. Application of the Acts Interpretation Act 1931

*The Acts Interpretation Act 1931* applies to this Order.

#### 6. Exemption from the requirement to be licensed under the Act

- (1) Under section 99(1)(a) of the Act, I exempt persons who specialise in carrying out the inspection of sewer and stormwater plumbing and drainage pipes using CCTV cameras from the requirement to be licensed under the Act.
- (2) This exemption only applies to sewer and stormwater plumbing and drainage pipes which have screw caps for inspection openings and does not apply to the inspection of sewer and drainage pipes which have –
  - (i) earthenware or concrete inspection openings; or
  - (ii) earthenware or concrete inspection openings with rubber ring seals.
- (3) Where an inspection opening does not have screw caps, the removal of those caps must be carried out by a licensed –
  - (i) Plumber Practitioner – Drainage; or
  - (ii) Plumber Practitioner (Certifier) – Drainage.

- closed season from 1 May 2013 for all State waters;
  - open season from 2 November 2013 for the “Western region”;
  - open season from 9 November 2013 for the “ non commercial fishery south eastern area”;
  - open season from 16 November 2013 for the “Eastern Region”;
  - closed season from 1 May 2014 for all State waters;

Where:

“**non commercial fishery south eastern area**” is defined to mean the area of the Eastern Region south of a line of latitude 43° 21.01’ South, running through Coal Point, Adventure Bay (Bruny island), excluding the D’Entrecasteaux Channel ;

“**western region**” is as defined in the *Fisheries (Rock Lobster) Rules 2011* which encompasses waters west of a line of longitude running due north of Point Sorell in the north and a line of longitude running due south of Whale Head in the south;

“**commercial fishery south eastern area**” is defined to mean the area of the Eastern Region south of a line of latitude 43° 21.0’ South, Penguin Island ( Bruny island), excluding Adventure Bay ( Bruny Island);

“waters between Eddystone Point and Penguin Island” is defined to mean the area of the Eastern Region bounded in the north on the east coast by the line of latitude at 41° 01' 0" South (Eddystone Point) and bounded in the south on the south east coast by the line of latitude at 43° 21' 00" South (Penguin Island, Bruny Island).
