ANTI-DISCRIMINATION ACT 1998

OFFICE OF THE ANTI-DISCRIMINATION COMMISSIONER, TASMANIA EXEMPTION/S GRANTED

The following exemption from the provisions of the *Anti-Discrimination Act 1998* (Tas) (the Act) has been granted:

Hobart Women's Shelter Inc (13/06/025) – Application for exemption granted under section 57 of the Act for a period of three years.

This exemption has been granted to permit Hobart Women's Shelter Inc to:-

- a) recruit and employ women only in all paid positions with the Hobart Women's Shelter Inc
- b) recruit and engage women only in all positions on the volunteer governance board of the Hobart Women's Shelter Inc

Granted on the 10th day of September 2013.

The exemption is for the period of three years subject to Hobart Women's Shelter Inc ensuring that:

- (a) it continues its efforts to engage men is supporting its work through its fundraising committee and in primary prevention activities and partnership projects;
- (b) on at least one occasion in the 12 months immediately after this order is made its members, officers, employees, volunteers and agents in Tasmania attend and participate in the Office of the Anti-Discrimination Commissioner's

community education and corporate training program to increase awareness of rights and obligations under the *Anti-Discrimination Act 1998* (Tas);

- (c) on at least one occasion in the 12 months immediately after this order is made it will organise and promote community education for its clients through the Office of the Anti-Discrimination Commissioner's community education and corporate training program to increase awareness of rights and obligations under the *Anti-Discrimination Act 1998* (Tas); and
- (d) it will report on or before 10 December 2014 to the Anti-Discrimination Commissioner on education and/or training undertaken in compliance with the conditions in (a) and (b) above, and on actions taken in reliance on this exemption.

A person may apply to the Anti-Discrimination Tribunal for a review of the Commissioner's decision **within 28 days from the date of this notice being published**.

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Proclamation under sections 9A and 52A of the *Roads and Jetties Act 1935*

This proclamation –

- (a) declares the intended new line of the Colebrook Main Road, the declaration taking effect, as specified in section 9A(4) of the *Roads and Jetties Act 1935*, 60 days after this proclamation is notified in the *Gazette*; and
- (b) declares that part of the Colebrook Main Road to be a limited access road and the places of access to that limited access road, these declarations taking effect, as specified in section 52A(2) of the *Roads and Jetties Act 1935*, on the opening of the relevant highway; and
- (c) revokes the proclamation notified in the *Gazette* as Statutory Rules 1989, No. 111.

(2) Proclamation under section 7 of the *Roads and Jetties Act 1935*

This proclamation amends an earlier proclamation (S.R. 1970, No. 67) by redefining the description and length of the Lady Barron Main Road on Flinders Island and revokes a related proclamation (S.R. 1978, No. 41).


