## FEE UNITS ACT 1997

THE *Fee Units Act 1997* provides for automatic changes in Government fees and charges in accordance with movements in the Hobart Consumer Price Index (CPI). The Fee Units Act also provides for adjustments to be made on the basis of factors other than movements in the CPI through a fee unit adjustment factor.

The Treasurer, Hon Lara Giddings MP, is satisfied that there are no special factors that would result in the increase in the costs of providing government services being less than the increase in the CPI. The Treasurer, therefore, has determined the fee unit adjustment factor for 2014–15 to be zero for the purposes of section 4 of the Fee Units Act.

In accordance with section 5 of the Fee Units Act, the value of a fee unit is increased by the increase in the CPI and for 2014–15 will be \$1.48.

### LIVING MARINE RESOURCES MANAGEMENT ACT 1995

#### NOTIFICATION OF ALTERATION TO THE TASMANIAN ROCK LOBSTER FISHERY MANAGEMENT PLAN

I, ROB GOTT, Director (Marine Resources) in the Department of Primary Industries, Parks, Water and Environment, pursuant to the delegated authority under Section 20(2) of the *Living Marine Resources Management Act 1995* and in accordance with section 57 of that Act, hereby notify that:

a. As a result of a review the Minister has accepted a recommendation to alter the management plan for the rock lobster fishery - *Fisheries (Rock Lobster) Rules 2011*.

b. The *Fisheries (Rock Lobster) Amendment Rules 2014*, amend the Fisheries (Rock Lobster) Rules 2011 by:

- establishment of the ability for the Minister to set a catch-cap for an area of the commercial rock lobster fishery;
- the requirement for commercial fishers to make telephone reports prior to fishing in and transiting through a catch-cap area;
- prohibition of double night shots by commercial fishers in the catch-cap area;
- the requirement to unload all rock lobster prior to or on completion of fishing in the catch-cap area;
- transiting arrangements for commercial fishers transiting a closed part of the fishery;
- the introduction of extreme circumstances / hardship carryover provisions;
- the repeal of provisions permitting interstate unloading;
- prohibition of the possession of rock lobster on a fishing vessel outside State waters;
- changes to the way over catch is administered with; and
- updated infringement notice offences and penalties.

c. The alterations take effect from 29 January 2014.

#### NOTICE OF DISPENSING OF REQUIREMENTS AND ISSUE OF MODIFIED PLANNING DIRECTIVE

I, BRYAN ALEXANDER GREEN, the Minister for Planning -

(a) having considered a modification prepared by the Tasmanian Planning Commission to the planning directive entitled "Planning Directive No. 4.1 – Standards for Residential Development in the General Residential Zone" (the original planning directive) and being satisfied that the modification is for the purpose of clarifying the original planning directive, and that the public interest will not be prejudiced -

i. in pursuance of section 16 of the *Land Use Planning and Approvals Act 1993* (the Act), dispense with the requirements of sections 10, 11 and 12 of the Act in relation to the modification; and

ii. in pursuance of section 16 of the Act and with reference to section 13 of the Act, give notice of the issue of the modified planning directive, entitled "Planning Directive No. 4.1 – Standards for Residential Development in the General Residential Zone", which consists of the original planning directive as modified in accordance with the modification; and

(b) in pursuance of section 13 of the Act, specify that the modified planning directive takes effect on 28 February 2014.

## GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Proclamation under section 2 of the *Civil Liability Amendment Act 2013*

This proclamation fixes 1 March 2014 as the day on which all the provisions of the *Civil Liability Amendment Act 2013* commence.

(2) Proclamation under section 2 of the *Crime (Confiscation of Profits) Amendment (Unexplained Wealth) Act 2013*

This proclamation fixes 1 March 2014 as the day on which all of the provisions of the *Crime (Confiscation of Profits) Amendment (Unexplained Wealth) Act 2013* commence.

(3) Proclamation under section 2 of the *Evidence (Children and Special Witnesses) Amendment Act 2013*

This proclamation fixes 1 March 2014 as the day on which all the provisions of the *Evidence (Children and Special Witnesses) Amendment Act 2013* commence.

(4) Proclamation under section 2 of the *Financial Transactions Reports Amendment Act 2013*

This proclamation fixes 1 March 2014 as the day on which the *Financial Transaction Reports Amendment Act 2013* commences.

(5) Proclamation under section 2 of the *Historic Cultural Heritage Amendment Act 2013*

This proclamation fixes 1 March 2014 as the day on which the *Historic Cultural Heritage Amendment Act 2013* commences.

(6) *Local Government (General) Amendment Regulations 2014*

These regulations amend the *Local Government (General) Regulations 2005* by prescribing that the uses of land specified in Land Use Codes provided to the councils by the Valuer-General are a variation factor when calculating general or service rates.

(7) *Local Government (Number of Councillors) Order 2014*

This order –

- (a) determines the number of persons to be elected as councillors of the following municipal areas:
  - (i) Derwent Valley;
  - (ii) Southern Midlands;
  - (iii) Waratah-Wynyard; and
- (b) amends Schedule 3 to the *Local Government Act 1993* by updating the number of councillors in respect of those municipal areas to give effect to this order.

(8) *Local Government (Casual Vacancies) Order 2014*

This order prevents vacancies in the offices of councillors for certain municipal areas from being filled by way of by-election or recount, so as to enable the effective implementation of the reduction, effected by the *Local Government (Number of Councillors) Order 2014*, in the number of councillors for those municipal areas.

(9) Proclamation under section 2 of the *Primary Produce Safety Act 2011*

This proclamation fixes 13 February 2014 as the day on which certain provisions of the *Primary Produce Safety Act 2011* commence.

(10) *Primary Produce Safety (General) Regulations 2014*

These regulations prescribe, for the purpose of the *Primary Produce Safety Act 2011* –

- (a) the application fee for an application for approval to be a food safety auditor; and
- (b) infringement notice offences and the penalties payable for those infringement notice offences.

(11) *Primary Produce Safety (Seafood) Regulations 2014*

These regulations prescribe, for the purposes of the *Primary Produce Safety Act 2011* –

- (a) the food safety scheme in respect of seafood; and
- (b) the accreditation requirements in respect of the production of seafood; and
- (c) other miscellaneous matters in relation to seafood.

(12) *Primary Produce Safety (Seed Sprouts) Regulations 2014*

These regulations prescribe, for the purposes of the *Primary Produce Safety Act 2011* –

- (a) the food safety scheme in respect of seed and seed sprouts; and
- (b) the accreditation requirements in respect of the production of seed and seed sprouts; and
- (c) other miscellaneous matters in relation to seed and seed sprouts.

(13) *Public Health (Smoke-free Areas) Regulations 2014*

These regulations declare certain pedestrian malls and bus malls to be smoke-free areas for the purposes of section 67B(1)(m) and (n) of the *Public Health Act 1997*.

(14) Proclamation under section 2 of the *Reproductive Health (Access to Terminations) Act 2013*

This proclamation fixes 12 February 2014 as the day on which the *Reproductive Health (Access to Terminations) Act 2013* commences.

(15) *Reproductive Health (Access to Terminations) Regulations 2014*

These regulations prescribe –

- (a) health services for the purposes of section 7(2) and (4) of the *Reproductive Health (Access to Terminations) Act 2013*; and
- (b) an offence under section 9(8) of that Act as an offence in respect of which an infringement notice may be issued and the penalty payable in respect of that offence.

(16) *Tasmanian Health Organisations Regulations 2014*

These regulations make provision for –

- (a) a Tasmanian Health Organisation to collect information, and provide it to the Department, for the purposes of statewide health system management and other purposes; and
- (b) a Tasmanian Health Organisation to assist with the travel and accommodation costs of patients, and their escorts, for the purpose of receiving health services.

(17) *Restricted Hire Vehicle Industry Amendment Regulations 2014*

These regulations amend the *Restricted Hire Vehicle Industry Regulations 2013* by removing, from the regulation prescribing motor vehicles for the purposes of paragraph (e) of the definition of *suitable vehicle* in section 84I(4) of the Act, a reference to a vehicle that is capable of operating a pre-booked general hire service in an area that the Commission determines is not serviced by taxis.

(18) Proclamation under section 2 of the *Youth Justice (Miscellaneous Amendments) Act 2013*

This proclamation fixes 1 March 2014 as the day on which the provisions of the *Youth Justice (Miscellaneous Amendments) Act 2013*, except sections 18, 19 and 44, commence.

(19) *Food Amendment Regulations 2014*

These regulations amend the *Food Regulations 2012* by omitting a regulation, relating to the primary production of seafood, consequent on the commencement of the *Primary Produce Safety (Seafood) Regulations 2014*.
