NOTICE OF THE MAKING OF STATUTORY RULES

IN ACCORDANCE with the provisions of the Rules Publication Act 1953, notice is given of the making of the following statutory rules:—

GENERAL PURPORT OR EFFECT of THE ABOVEMENTIONED STATUTORY RULES

(1) *Ambulance Services (Paramedic) Regulations 2014*

These regulations prescribe the qualification required for a person to be a paramedic, in certain circumstances, for the purposes of the *Ambulance Service Act 1982*.

(2) *Health (Fees) Amendment Regulations 2014*

These regulations amend the *Health (Fees) Regulations 2007* by increasing the fees payable by non-nursing-home-type patients in accordance with national consumer price index movements.

(3) *Poisons Amendment Regulations (No. 2) 2014*

These regulations amend the *Poisons Regulations 2008* by –

- (a) authorising certain persons to possess and supply nitrous oxide, methoxyflurane or salbutamol in certain circumstances; and
- (b) updating certain legislative references.
