ENVIRONMENTAL MANAGEMENT AND POLLUTION CONTROL (UNDERGROUND PETROLEUM STORAGE SYSTEMS) REGULATIONS 2010

Notice of Issuing and Varying Guidelines

NOTICE is hereby given of the issuing of Technical Guideline UPSS2: Underground Petroleum Storage Systems – Decommissioning Assessment – Sampling and Risk Assessment Requirements under regulation 42(1) of the Environmental Management and Pollution Control (Underground Petroleum Storage Systems) Regulations 2010 (UPSS Regulations).

Technical Guideline UPSS2 provides detail on the sampling and risk assessment that must be conducted as part of the assessment requirements when an underground petroleum storage system (UPSS) is permanently decommissioned. The decommissioning assessment must determine whether petroleum hydrocarbons have contaminated the soil and/or groundwater within the vicinity of the storage system and whether this contamination is likely to cause an unacceptable risk to a receptor (including environmental and human receptors). The guideline is referred to in regulations 30(7)(b) and 31(2)(b) of the UPSS Regulations.

Notice is also hereby given of the varying of *Technical Guideline UPSS1: UPSS Decommissioning Assessment Report Requirements* under regulation 42(2) of the UPSS Regulations.

UPSS1 provides detail on the content that must be included in a Decommissioning Assessment Report and has been updated to reflect requirements in UPSS2. The guideline is referred to in regulations 30(7)(d) and 31(2)(d) of the UPSS Regulations.
