KENTISH COUNCIL

RESERVES, PARKS AND GARDENS BY-LAW

BY-LAW NO 1 OF 2014

A By-law of the Kentish Council, made under Section 145 of the Local Government Act 1993 to amend By-law No. 1 of 2012 by including police as authorised officers and giving the Council power to remove any shelter or vehicle that is being used for the purposes of camping where there is a breach of the time limit requirements under clause 17 of the By-law.

PART 1 - PRELIMINARY

1. Short Title

This By-law may be cited as the "Reserves, Parks and Gardens Amending By-law".

2. Amendment

The Reserves, Parks and Gardens By-law No. 1 of 2012 ("**the By-law**") and published in the Tasmanian Government Gazette on Thursday, 5 December 2012 on pages 2238 to 2261 is amended as follows:

- (a) The definition of "authorised officer" is amended by deleting the semicolon after the word 'By-law' and adding the words "or a police officer of the Tasmanian police force."
- (b) By inserting a new sub-clause 7 into clause 16 of the By-law in the following terms:

"Where there is a breach of sub-clauses 2 or 3 of clause 16 of the By-law the Council may remove any shelter or vehicle that is being used for the purpose of camping."

3. Interpretation

In this By-law, unless the context otherwise indicates:-

"authorised officer" includes the Manager and any other person appointed by the Manager as an officer for the purposes of this By-law or a police officer of the Tasmanian police force;


