GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Agricultural and Veterinary Chemicals (Tasmania) Regulations 2014*

These regulations –

- (a) declare the *Agricultural and Veterinary Chemicals (Control of Use) Act 1995* to be an eligible law for the purpose of the Agvet Code of Tasmania; and
- (b) specify that the *Poisons Act 1971* has effect despite that Code; and
- (c) are made consequentially on the repeal of the *Agricultural and Veterinary Chemicals (Tasmania) Regulations 2004* under section 11 of the *Subordinate Legislation Act 1992*.

(2) *Economic Regulator (Metro Bus Fares) Order 2014*

This order –

- (a) specifies the maximum full adult fares that Metro Tasmania Pty. Ltd. may charge on scheduled route services during the period of 2 years following the day on which the order takes effect; and
- (b) specifies the minimum discount to be applied to full adult fares paid by means of a Metro Greencard; and
- (c) revokes the *Government Prices Oversight (Metro Bus Fares) Order 2009*.

(3) Proclamation under section 7 of the *Roads and Jetties Act 1935*

This proclamation –

- (a) declares certain roads, or portions of roads, to be subsidiary roads classified as main roads; and
- (b) declares that the Pegarah Secondary Road ceases to be a subsidiary road; and
- (c) amends an earlier proclamation (S.R. 1970, No. 67) by omitting reference to the Pegarah Secondary Road and redefining the description and length of the King Island Main Road; and
- (d) revokes an earlier proclamation, S.R. 1971, No. 32.

(4) *Vehicle and Traffic (Driver Licensing and Vehicle Registration) Amendment (Charitable Exemption) Regulations 2014*

These regulations amend the *Vehicle and Traffic (Driver Licensing and Vehicle Registration) Regulations 2010* by –

- (a) providing an exemption from motor tax for certain heavy vehicles in specified circumstances; and
- (b) effecting minor statute law revision.

(5) *Youth Justice Amendment Regulations 2014*

These regulations amend the *Youth Justice Regulations 2009* by prescribing the Secretary of the Department administering those regulations as a person who may apply to the Court for an order if it appears to the Secretary that a youth has contravened a rehabilitation program order.

(6) *Guardianship and Administration (Corresponding Law) Notice 2014*

This notice declares the *Mental Capacity Act 2005* of the United Kingdom to be a corresponding law for the purposes of section 81 of the *Guardianship and Administration Act 1995*.
