### INDUSTRIAL HEMP

*Regulatory Impact Statement: Industrial Hemp Bill 2015*

#### Invitation for public comment

ON 19 January 2015, Jeremy Rockliff, Minister for Primary Industries and Water announced that the Government would introduce special purpose legislation to simplify regulation of the industrial hemp sector in Tasmania.

The *Industrial Hemp Bill 2015* will enable research in, cultivation and supply of industrial hemp in accordance with a licensing scheme to be administered by the Secretary of the Department of Primary Industries, Parks, Water and Environment.

A Regulatory Impact Statement (RIS) regarding the *Industrial Hemp Bill 2015* has been prepared by the Department of Primary Industries, Parks, Water and Environment to examine the impact of the draft legislation on the hemp industry and present the likely costs and benefits that would flow from its adoption in comparison with other options.

#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

##### (1) Proclamation under section 2 of the *Co-operatives National Law (Tasmania) Act 2015*

This proclamation fixes 1 September 2015 as the day on which the provisions of the *Co-operatives National Law (Tasmania) Act 2015* commence.

##### (2) *Co-operatives National Law (Tasmania) Local Regulations 2015*

These regulations –

- (a) prescribe certain matters for the purposes of the *Co-operatives National Law (Tasmania)* and the *Co-operatives National Regulations (Tasmania)*; and
- (b) prescribe certain fees payable under the *Co-operatives National Law (Tasmania)*; and
- (c) enable any existing co-operative to continue to operate under the rules that applied to the co-operative before the commencement of the *Co-operatives National Law (Tasmania) Act 2015*.

##### (3) *Poisons Amendment Regulations (No. 2) 2015*

These regulations amend the *Poisons Regulations 2008* to add certain substances to the list of substances that are specified psychotropic substances for the purposes of section 38(1)(b) of the *Poisons Act 1971*.

##### (4) *Radiation Protection Amendment Regulations 2015*

These regulations amend the *Radiation Protection Regulations 2006* by –

- (a) prescribing a fee for a licence to possess and use radiation apparatus that is a linear accelerator; and
- (b) increasing certain fees from the date of gazettal of these regulations and from 1 July 2016.

(5) Proclamation under section 52A of the *Roads and Jetties Act 1935*

This proclamation –

- (a) amends an earlier proclamation (S.R. 1997, No.52) made under the *Roads and Jetties Act 1935* by –
  - (i) omitting a reference to a superseded plan and substituting a reference to a new plan; and
  - (ii) specifying an additional place of access to the part of the Lyell Highway declared to be a limited access road; and
- (b) revokes a related proclamation (S.R. 2011, No. 106).

(6) *Poisons (Declared Restricted Substances) Amendment Order 2015*

This order amends the *Poisons (Declared Restricted Substances) Order 1990* to add certain substances to the list of substances to which section 36 of the *Poisons Act 1971* applies.


