HEALTH PROFESSIONALS (SPECIAL EVENTS EXEMPTION) ACT 1998

ORDER: DECLARATION OF SPECIAL EVENT - CRICKET WORLD CUP 2015

I, MICHAEL FERGUSON, Minister for Health, declare under section 4 of the *Health Professionals (Special Events Exemption) Act 1998* (the Act), that the International Cricket Council (ICC) Cricket World Cup 2015 is a Special Event for the purposes of the Act. Terms used in this order have the meaning given to them by the Act.

The exemption period given by this order is 9 February 2015 to 30 March 2015.

This order is subject to the following conditions:

1. Health care services provided in health care facilities such as hospitals and day procedure centres must only be provided by persons registered under the Health Practitioner Regulation National Law.

2. Visiting health professionals intending to provide health care services outside health care facilities in Tasmania under this declaration must first give notice to the Australian Government's Major Events Taskforce, Office of Sport, Department of Health, MDP 705 – GPO Box 9848 Canberra ACT 2601.
3. This declaration does not authorise visiting health professionals to issue prescriptions for controlled substances.
4. Visiting health professionals bringing controlled substances into Tasmania must first declare those substances to the Therapeutic Goods Administration (TGA) in accordance with any TGA requirements.

RULES PUBLICATION ACT 1953

NOTICE OF THE MAKING OF STATUTORY RULES

IN ACCORDANCE with the provisions of the *Rules Publication Act 1953*, notice is given of the making of the following statutory rules:—

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Electoral Regulations 2015*

These regulations –

- (a) prescribe the contents of writs for elections; and
- (b) prescribe the printing order for names on batches of ballot papers subsequent to the first batch; and
- (c) are made consequentially on the repeal of the *Electoral Regulations 2005* under section 11 of the *Subordinate Legislation Act 1992*.

(2) *Prepaid Funerals Regulations 2015*

These regulations –

- (a) exempt certain deposit schemes and certain classes of prepaid funeral agreements from the application of certain provisions of the *Prepaid Funerals Act 2004*; and
- (b) are made consequentially on the repeal of the *Prepaid Funerals Regulations 2005* under section 11 of the *Subordinate Legislation Act 1992*.
