“eastern waters” is defined to mean the area of State waters adjacent to the north east, east and south east coasts of Tasmania, south of the line of latitude 40 ° 39’ 18” S, east of the line of longitude 147 ° 00’ 00” E on the north east coast and east of the line of longitude 147 ° 09’ 44” E on the south east coast.
