PLACES OF ASSEMBLY

ANTI-DISCRIMINATION ACT 1998

OFFICE OF THE ANTI-DISCRIMINATION COMMISSIONER, TASMANIA

EXEMPTION/S GRANTED

THE following application for exemption from the provisions of the *Anti-Discrimination Act 1998* (Tas) (the Act) has been granted:

1. University of Tasmania – 15/05/027– Application for an exemption granted under section 57 of the Act for a period of three years.

This exemption has been granted to permit:

- (a) the University of Tasmania to develop and implement the University of Tasmanian Aboriginal and Torres Strait Islander policy framework;
- (b) the University of Tasmanian to develop and implement the University of Tasmania Aboriginal Employment Strategy;

- (c) the University of Tasmania to establish and maintain the University of Tasmania Aboriginal Policy Working Group;
- (d) the University of Tasmania Aboriginal Policy Working Group to consider, develop and recommend actions and approaches (however named or described) within the University of Tasmanian Aboriginal and Torres Strait Islander policy framework for the University of Tasmania to implement;
- (e) the University of Tasmania to create and maintain the position of Pro Vice-Chancellor Aboriginal Research and Leadership; and
- (f) the University of Tasmania and its senior staff and Human Resources Department, and the University of Tasmania Aboriginal Policy Working Group and its members, to do those things that are reasonably necessary to undertake the actions referred to in paragraphs (a)-(e) above.

Granted on the 14th day of July 2015.

The exemption is for the period of three years subject to the fulfilment of the conditions that University of Tasmania:

- a) reports on or before 31 January 2016 to the Anti-Discrimination Commissioner on actions taken in reliance on this exemption; and
- b) on at least one occasion in the 12 months immediately after this order is made, organise and promote training/education for the University of Tasmania's Human Resources Department, the University of Tasmania's Aboriginal Policy Working Group, and the University of Tasmania Aboriginal Staff Group through the Office of the Anti-Discrimination Commissioner's community education program to increase awareness of rights and obligations under the *Anti-Discrimination Act 1998* (Tas).

A person may apply to the Anti-Discrimination Tribunal for a review of the Commissioner's decision within 28 days from the date of this notice being published.

CLIMATE CHANGE (GREENHOUSE GAS EMISSIONS) REGULATIONS 2012

Notice

I, MATTHEW GUY GROOM, for the purposes of section 6 of the *Climate Change (Greenhouse Gas Emissions) Regulations 2012*, give notice of Tasmania's baseline figure and reduction in greenhouse gas emissions for the financial year ending 30 June 2013.

The total reported carbon dioxide equivalent emissions for Tasmania in the baseline year ending 30 June 1990 were 17.3 mega-tonnes. Reported carbon dioxide equivalent emissions for the year ending 30 June 2013 totalled 1.7 mega-tonnes.

This represents an overall reduction in net emissions of approximately 15.6 mega-tonnes or 90 per cent from 1989-90 levels.
