### ANTI-DISCRIMINATION ACT 1998

OFFICE OF THE ANTI-DISCRIMINATION COMMISSIONER, TASMANIA

#### EXEMPTION/S GRANTED

THE following application for exemption from the provisions of the *Anti-Discrimination Act 1998* (Tas) (the Act) has been granted:

1. Victorian Aboriginal Legal Service Co-operative Limited – 15/06/061 – Application for an exemption granted under section 57 of the Act for a period of three years.

This exemption has been granted to Victorian Aboriginal Legal Service Co-operative Limited to recruit and employ Aborigines and/or Torres Strait Islanders only to the positions of Aboriginal Client Services Officer within the offices of the Tasmanian Aboriginal Community Legal Service for the purpose of:

- a) ensuring clients of the Tasmanian Aboriginal Community Legal Service are provided with culturally appropriate and supportive access to legal services in Tasmania;

- b) improving client connections and engagement in the Tasmanian Aboriginal Community Legal Service processes; and
- c) providing employment opportunities for Aborigines and/or Torres Strait Islanders through the establishment of the identified positions of Aboriginal Client Services Officer within Tasmanian Aboriginal Community Legal Service.

Granted on the 15th day of July 2015.

The exemption is for the period of three years subject to the fulfilment of the conditions by that Victorian Aboriginal Legal Service Co-operative Limited:

- a) reports on or before 31 January 2016 to the Anti-Discrimination Commissioner on actions taken in reliance on this exemption; and
- b) on at least one occasion in the 12 months immediately after this order is made, organise and promote community education for the staff and clients of Tasmanian Aboriginal Community Legal Service through the Office of the Anti-Discrimination Commissioner's community education program to increase awareness of rights and obligations under the Anti-Discrimination Act 1998 (Tas).

A person may apply to the Anti-Discrimination Tribunal for a review of the Commissioner's decision **within 28 days from the date of this notice being published.**

#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

##### (1) *Inland Fisheries (Recreational Fishing) Amendment Regulations 2015*

These regulations amend the *Inland Fisheries (Recreational Fishing) Regulations 2009* to provide for the issuing of infringement notices in respect of taking salmon in excess of the maximum size limit from certain waters.

##### (2) Proclamation under section 2 of the *Liquor Licensing Amendment (Liquor and Gaming Administrative Restructuring) Act 2015*

This proclamation fixes 12 August 2015 as the day on which the *Liquor Licensing Amendment (Liquor and Gaming Administrative Restructuring) Act 2015* commences.

##### (3) *Therapeutic Goods (Exemption) Order 2015*

This order –

- (a) exempts certain persons who provide a needle and syringe service under the *Public Health Act 1997* from the operation of section 22(1) and (2) of the *Therapeutic Goods Act 2001*; and
- (b) revokes the *Therapeutic Goods (Exemption) Order 2011*.
