ANTI-DISCRIMINATION ACT 1998

OFFICE OF THE ANTI-DISCRIMINATION COMMISSIONER, TASMANIA

EXEMPTION/S GRANTED

THE following application for exemption from the provisions of the *Anti-Discrimination Act 1998* (Tas) (the Act) has been granted:

 Karinya Young Women's Service Inc (15/04/046) – Application for an exemption granted under section 57 of the Act for a period of three years.

This exemption has been granted to permit Karinya Young Women's Service Inc to recruit and employ women only in the identified position of Youth Crisis Accommodation Worker. The exemption is granted on the basis that:

- a) the discrimination is for the purposes of operating a crisis accommodation service for young women aged between 13-20 who are homeless or at risk of homelessness, being a scheme for the benefit of a group—women at risk of homelessness—that has special needs because of gender; and
- b) being a women is a genuine occupational requirement of working with young women who require crisis accommodation and other services provided by Karinya Young Women's Service Inc.

Granted on the 24th day of May 2015.

The exemption is for the period of three years subject to the fulfilment of the conditions that Karinya Young Women's Service Inc:

 a) report on or before 30 November 2015 to the Anti-Discrimination Commissioner on actions taken in reliance on this exemption; and b) on at least one occasion in the 12 months immediately after this order is made Karinya Young Women's Service Inc will organise and promote community education training for its staff and clients through the Office of the Anti-Discrimination Commissioner's training and education program to increase awareness of rights and obligations under the Anti-Discrimination Act 1998 (Tas)

A person may apply to the Anti-Discrimination Tribunal for a review of the Commissioner's decision within 28 days from the date of this notice being published.

Personal Information Protection

PERSONAL INFORMATION PROTECTION ACT 2004

Exemption under section 14

I, VANESSA GOODWIN, Minister for Justice, being and as the Minister responsible for the administration of the Personal Information Protection Act 2004 ("the Act"), having considered the application dated 9 December 2014 made by the Assistant Commissioner of Police (Planning and Development) under section 13 of the Act for exemption from compliance with Personal Information Protection Principle 2(1) in respect of personal information of individuals as is contained in the Police Service records which is proposed to be disclosed to the Secretary of the Department of Treasury and Finance for use by the Commissioner for Licensing in performing his functions under the Liquor Licensing Act 1990; and being satisfied that the public benefit of exemption from compliance with the principle outweighs to a substantial degree the public benefit from compliance with the principle, hereby approve the application.

Details of the Application

The Police Service as the personal information custodian within the meaning of the *Personal Information Protection Act 2004* (the Act) holds personal information of individuals in its records system. The Police Service applied under section 13 of the Act for an exemption under section 14 to allow the Police Service to disclose information in its records system to the Secretary of the Department of Treasury and Finance (the Agency) for use by the Commissioner for Licensing in performing his statutory functions under the *Liquor Licensing Act 1990*.

Disclosure of the information by the Agency is also governed by the provisions of the Act.
