PUBLIC NOTICE - DATES OF CLOSING OF THE ROCK LOBSTER FISHERY

RULE 11 OF THE FISHERIES (ROCK LOBSTER) RULES 2011

I, Robert Gott, Director (Marine Resources) in the Department of Primary Industries, Parks, Water and Environment, pursuant to my delegated power under section 20 (1) of the *Living Marine Resources Management Act 1995*, in accordance with Rule 11 (2) of the *Fisheries (Rock Lobster) Rules 2011*, hereby determine that:

- the part of the rock lobster fishery comprising of the taking of rock lobster in the "Maria Island Zone" will be closed from 25 June 2016; and
- (2) the part of the rock lobster fishery comprising of activities by way of setting rock lobster pots, setting rock lobster rings and diving for rock lobster in the "Maria Island Zone" will be closed from 25 June 2016.

where

"Maria Island Zone" is defined to mean the area of State waters adjacent to the east coast of Tasmania bounded in the north by the line of latitude at 42° 10' South and bounded in the south by the line of latitude at 42° 49' South, and also including all the waters within Great Oyster Bay north of latitude at 42° 10" South.

Words and expressions used in this public notice have the same meaning as in the *Living Marine Resources Management Act 1995*, the *Fisheries (Rock Lobster) Rules 2011*.

Due to the presence of the toxic algae Alexandrium tamarence, the rock lobster fishery between Wineglass Bay and the southern end of Marion Bay is closed from Saturday 25 June 2015- while samples are taken and tested to determine toxin levels in lobster and also to ensure critical export market access is not compromised.
