REGULATORY IMPACT STATEMENT:
Firearms Amendment Regulations 2017

Invitation for Public Comment

Submissions are invited on the proposed *Firearms Amendment Regulations 2017*, which are intended to update the minimum firearm storage requirements that must be complied with by firearm licence holders.

The objective of the proposed amendment Regulations is to achieve both the movement of the storage requirements from the *Firearms Act 1996* to the *Firearm Regulation 2016*, where they can be more effectively updated in the future as technology and community expectations change, and to update the minimum storage requirements that have not changed in the 20 years since the *Firearms Act 1996* commenced.

(2) *Registration to Work with Vulnerable People (Risk Assessment for Child-related Activities) Amendment Order 2016*

This order amends the *Registration to Work with Vulnerable People (Risk Assessment for Child-related Activities) Order 2014* by revising certain provisions in relation to the conduct of risk assessments, and additional risk assessments, to ensure the safety, welfare and protection of vulnerable persons.
