## Electricity Supply Industry

**GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES**

(1) *Associations Incorporation Regulations 2017*

These regulations –

- (a) specify certain requirements in relation to documents under the *Associations Incorporation Act 1964* and certain fees and penalties payable in relation to matters under that Act; and
- (b) are made consequentially on the repeal of the *Associations Incorporation Regulations 2007* under section 11 of the *Subordinate Legislation Act 1992*.

(2) *Associations Incorporation (Model Rules) Regulations 2017*

These regulations –

- (a) set out model rules for the purposes of the *Associations Incorporation Act 1964*; and
- (b) are made consequentially on the repeal of the *Associations Incorporation (Model Rules) Regulations 2007* under section 11 of the *Subordinate Legislation Act 1992*.

(3) *Australian Consumer Law (Tasmania) (Code of Practice for Fuel Price Boards) Regulations 2017*

These regulations prescribe a code of practice for fuel price boards, for the purposes of the *Australian Consumer Law (Tasmania) Act 2010*, that prescribes the requirements in relation to –

- (a) the display of fuel prices on fuel price boards; and
- (b) the manner in which changed fuel prices must be displayed on fuel price boards.

(4) Proclamation under section 2 of the *Community Protection (Offender Reporting) Amendment Act 2016*

This proclamation fixes 29 November 2017 as the day on which the *Community Protection (Offender Reporting) Amendment Act 2016* commences.

(5) *Community Protection (Offender Reporting) Amendment Regulations 2017*

These regulations amend the *Community Protection (Offender Reporting) Regulations 2016* by –

- (a) prescribing a police officer of or above the rank of sergeant as an authorised person; and
- (b) prescribing the *Child Protection (Child Sex Offender Government Agency Registration) Act 2016* of New Zealand as a corresponding Act; and
- (c) prescribing a registration order under that Act as a corresponding offender reporting order; and
- (d) adding certain new personal details to the personal details listed in section 17(1) of the *Community Protection (Offender Reporting) Act 2005*; and
- (e) prescribing certain entities for the purposes of section 44B of that Act.

(6) Proclamation under section 2 of the *Domestic Violence Orders (National Recognition) Act 2016*

This proclamation fixes 25 November 2017 as the day on which the *Domestic Violence Orders (National Recognition) Act 2016* commences.

(7) *Domestic Violence Orders (National Recognition) Regulations 2017*

These regulations –

- (a) for the purposes of section 6(2) of that Act, amend the list of interstate DVOs specified in subsection (1) of that section, by omitting certain orders from that list and adding certain new orders to that list; and
- (b) for the purposes of section 7(2) of that Act, amend the list of registered foreign orders specified in subsection (1) of that section, by omitting certain foreign orders from that list and adding certain new foreign orders to that list.

(8) *Environmental Management and Pollution Control (Amendment of Schedule 2) Order 2017*

This order amends Schedule 2 to the *Environmental Management and Pollution Control Act 1994* by adding certain waste tyre storage depots to the list of Level 2 activities relating to waste treatment and disposal set out in item 3 of that Schedule.

(9) *Environmental Management and Pollution Control (Environmental Infringement Notices) Amendment Regulations 2017*

These regulations amend the *Environmental Management and Pollution Control (Environmental Infringement Notices) Regulations 2016* by omitting certain offences specified in certain Acts and regulations as offences in relation to which an environmental infringement notice may be issued.



(10) *Environmental Management and Pollution Control (General) Regulations 2017*

These regulations –

- (a) prescribe the fees payable in respect of certain permits under the *Land Use Planning and Approvals Act 1993*, orders under the *State Policies and Projects Act 1993*, environment protection notices, environmental improvement programmes and certain other matters; and
- (b) prescribe the times when, or periods within which, those fees are payable; and
- (c) provide for certain exemptions from liability to pay those fees; and
- (d) prescribe certain offences as offences in relation to which an environmental infringement notice may be served; and
- (e) rescind the *Environmental Management and Pollution Control (General Fees) Regulations 2007*.

(11) Proclamation under section 2 of the *Workers Rehabilitation and Compensation Amendment Act 2017*

This proclamation fixes 1 January 2018 as the day on which the *Workers Rehabilitation and Compensation Amendment Act 2017* commences.
