#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

- (1) Proclamation under section 7 of the *Roads and Jetties Act 1935*

This proclamation –

- (a) declares that Pine Main Road (consisting of a combination of Mission Hill Road and part of Main Road) and Preservation Secondary Road (known as Preservation Drive) cease to be subsidiary roads for the purposes of the *Roads and Jetties Act 1935*; and
- (b) consequentially amends and revokes earlier proclamations.

- (2) Proclamation under section 2 of the *Terrorism (Restrictions on Bail and Parole) Act 2018*

This proclamation fixes 14 December 2018 as the day on which the provisions of the *Terrorism (Restrictions on Bail and Parole) Act 2018* commence.

- (3) Proclamation under section 2 of the *Sentencing Amendment (Phasing Out Of Suspended Sentences) Act 2017*

This proclamation fixes 14 December 2018 as the day on which the provisions of the *Sentencing Amendment (Phasing Out Of Suspended Sentences) Act 2017*, except sections 8, 10 and 19, commence.

- (4) Proclamation under section 2 of the *Police Offences Amendment (Prohibited Insignia) Act 2018*

This proclamation fixes 1 January 2019 as the day on which the provisions of the *Police Offences Amendment (Prohibited Insignia) Act 2018* commence.

- (5) *Community Protection (Offender Reporting) Amendment Regulations 2018*

These regulations amend the *Community Protection (Offender Reporting) Regulations 2016* by updating the definition of “corresponding law” to include a reference to the *Child Sex Offenders Registration Act 2006* of South Australia.
