"north eastern waters" is defined to mean the area of State waters adjacent to the north east coasts of Tasmania, east of the line of longitude 146° 32.000' East (Point Sorell) on the north coast, and north of the line of latitude 41° 16.500' South (St Helens Point) on the east coast.

1. I determine that the dates of closing of the commercial dive fishery in State water adjacent to Eddystone Point to the activities of the take of periwinkles (Genus *Turbo*) by the holder of a fishing licence (commercial dive) are as follows:

from 19 January 2018 to 31 August 2018 inclusive; and

2.
