

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Corrections Regulations 2018*

These regulations –

- (a) provide for a range of matters relating to the management of prisons and the discipline, welfare and release of prisoners and detainees; and
- (b) rescind the *Corrections Regulations 2008*.

(2) Proclamation under section 2 of the *Heavy Vehicle National Law (Tasmania) Act 2013*

This proclamation fixes 1 August 2018 as the day on which section 38 of the *Heavy Vehicle National Law (Tasmania) Act 2013* commences.

(3) *Inland Fisheries (Recreational Fishing) Amendment Regulations 2018*

These regulations amend the *Inland Fisheries (Recreational Fishing) Regulations 2009* by –

- (a) prescribing waters available for fishing only by people under the age of 18 years; and
- (b) prescribing new daily bag limits for salmon, blackfish and brook trout taken from certain waters; and
- (c) prescribing new size limits for salmon taken from certain waters; and
- (d) removing the restriction that fish may only be taken from Huntsman Lake by means of a lure; and
- (e) updating the Schedule of infringement notice offences; and
- (f) making other miscellaneous minor amendments.

(4) *Inland Fisheries (Seasons and Waters) Amendment Order 2018*

This order amends the *Inland Fisheries (Seasons and Waters) Order 1996* by –

- (a) replacing the references to juvenile angling pond with references to junior angling development fishery and changing the age limit for taking fish from such waters from 16 to 18; and
- (b) updating the scientific name for estuary perch; and
- (c) prescribing a new boundary for taking acclimatised fish in the Leven River and the River Derwent.

(5) *Marine and Safety (Infringement Notices) Amendment Regulations 2018*

These regulations amend the *Marine and Safety (Infringement Notices) Regulations 2017* to allow infringement notices to be issued for certain new offences under the *Marine and Safety (General) Regulations 2013*.

(6) *Traffic (Electronic Billboards) Regulations 2018*

These regulations prescribe certain devices that are not taken to be electronic billboards for the purposes of the *Traffic Act 1925*.


