Section 21

REVOCATION OF GENERAL AUTHORITY

I, Mary Louise Conway, Acting Chief Veterinary Officer, hereby revoke the General Authority for the Importation of Cattle made under section 18 of the *Animal Health Act 1995* dated 9th January 2017 and published in the *Tasmanian Government Gazette* on the 18th January 2017.

ANIMAL HEALTH ACT 1995

Section 18

GENERAL AUTHORITY FOR THE IMPORTATION OF CATTLE

I, Mary Louise Conway, Acting Chief Veterinary Officer, hereby issue a General Authority for the Importation of Cattle.

The following conditions apply:-

- 1) The cattle must be inspected by the owner or person in charge within 7 days prior to movement to Tasmania and found free of signs of disease.
- 2) The cattle must not be known or suspected of being infected with, or exposed to a List A or List B disease, other than Johne's Disease, within 42 days prior to movement to Tasmania commencing.
- The herd of origin must not be subject to any animal movement restrictions.
- 4) The herd or herds of origin must have existed for at least 3 years prior to export. Changes of ownership or location need not disqualify the herd or herds if the certifying authority is satisfied that the disease monitoring of the herd or herds has been adequate.
- 5) Cattle being imported must either be:
 - a) Tested for Enzootic Bovine Leucosis with the ELISA test within 42 days before shipment with negative results. Unweaned calves less than 12 weeks of age being transported with their dams do not require testing for EBL. If samples are pooled, no more than 10 sera or 30 milk samples may be combined in each pool; or
 - b) Dairy cattle from a registered dairy herd accredited as Monitored Negative or better according to the national guidelines for Enzootic Bovine Leucosis Control; or
 - c) Beef or beef/dairy cross cattle from a beef herd in Victoria, South Australia, Western Australia (excluding the cattle tick infected area), New South Wales (excluding North Coast Local Land Service), or Queensland (excluding the cattle tick infested area), in which there has been no evidence of Enzootic Bovine Leucosis infection in the last 3 years.
- 6) Cattle that are infected, or suspected of being infected, with Johne's Disease may be imported provided that all other conditions have been met. The purchaser or recipient of those cattle must be advised that the cattle are infected or suspected of being infected with Johne's Disease.
- 7) The owner or person in charge of the animals in the exporting State or Territory must certify within 7 days prior to movement to Tasmania that, to the best of their knowledge, all the above conditions have been met.
- 8) A Stock Inspector or Government Veterinary Officer in the state of origin must certify that after due enquiry, they have no reason to doubt the 'owner declaration' required by condition 7.
- All certification must be in a form approved by the Chief Veterinary Officer, and must be presented to an inspector when the animals arrive in Tasmania.


