#### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) Luxury Hire Car Industry Regulations 2018

These regulations -

- (a) prescribe for the purpose of the Taxi and Hire Vehicle Industries Act 2008
  - (i) the licensing, operating and equipment requirements of luxury hire cars; and
  - (ii) the fees payable in respect of the licensing of luxury hire cars and other related matters; and
  - (iii) other miscellaneous matters; and
- (b) rescind the *Luxury Hire Car Industry Regulations 2008* and its amending legislation.

#### (2) Taxi Industry Regulations 2018

These regulations -

- (a) prescribe for the purposes of the Taxi and Hire Vehicle Industries Act 2008
  - (i) the licensing, operating and equipment requirements of taxis; and
    - (ii) the appointment and duties of authorised meter adjusters; and
    - (iii) the fares, surcharges and tariffs to be charged by taxis; and
    - (iv) the fees payable in respect of the licensing of taxis and other related matters; and
  - (v) other miscellaneous matters; and
- (b) rescind the Taxi Industry Regulations 2008 and its amendment legislation.

#### 910

(3) Traffic (Compliance and Enforcement) Amendment (Taxis and Luxury Hire Cars) Regulations 2018

These regulations amend the *Traffic (Compliance and Enforcement) Regulations 2017* by revising the schedule of traffic infringement notices consequent on the making of the *Taxi Industry Regulations 2018* and the *Luxury Hire Car Industry Regulations 2018*.

(4) Taxi and Hire Vehicle Industries (Review of Decisions) Amendment Regulations 2018

These regulations amend the *Taxi and Hire Vehicle Industries (Review of Decisions) Regulations 2010* by updating references consequent on the making of the *Taxi Industry Regulations 2018* and the *Luxury Hire Car Industry Regulations 2018*.

(5) *Restricted Hire Vehicle Industry Amendment Regulations 2018* 

These regulations amend the *Restricted Hire Vehicle Industry Regulations 2013* by updating provisions consequent on the making of the *Taxi Industry Regulations 2018*.
