RULE 12 OF THE *FISHERIES (COMMERCIAL DIVE) RULES 2011*

Pursuant to the powers under the *Fisheries (Commercial Dive) Rules 2011* ("the Rules") that were delegated to the Director (Marine Resources) on 2 July 2018 by the Minister, acting pursuant to section 20(1) of the *Living Marine Resources Management Act 1995* ("the Act"), under Rule 12 of the Rules:

1. I determine that the dates of closing of the commercial dive fishery in State water of **Georges Bay** to the activities of the take of *Heliocidaris Erythrogramma* sea urchins by the holder of a fishing licence (commercial dive) are as follows:
 - from 26 September 2018 to 31 August 2019 inclusive; and,
2. I also determine that, for the period specified in this notice, if the holder of a fishing licence (commercial dive) on a fishing trip takes *Heliocidaris Erythrogramma* sea urchins in the commercial dive fishery in State waters outside the area specified in this notice, then the commercial dive fishery in the area specified in this notice is closed to the holder of the fishing licence (commercial dive) to the activities of entering the water by swimming or diving;

where, **Georges Bay** is defined as State waters enclosed by an imaginary line commencing at Grants Point then following the line of high water around Georges Bay to St Helens Point then running straight to the point of commencement.

Any expression used in this public notice having a particular meaning under the Act or the Rules has the same meaning in this public notice as it has in the Act or the Rules.


