WATER MANAGEMENT ACT 1999

Section 11 Exemption Order

WATERCOURSE AUTHORITIES WITHIN SPECIFIED IRRIGATION DISTRICTS

I, Guy Barnett, Minister for Primary Industries and Water, acting pursuant to section 11 of the *Water Management Act 1999* hereby exempt all persons who wish to convey water, that has been taken and stored pursuant to this Act, via any watercourse located within the Irrigation Districts listed below, from obtaining a Watercourse Authority under Part 6A of this Act, subject to them obtaining the prior approval of the relevant Responsible Water Entity to convey the water.

- (1) River Clyde Irrigation District
- (2) Cressy Longford Irrigation Water District
- (3) Lake Leake/Elizabeth/Macquarie River Irrigation District
- (4) Tooms Lake/Macquarie River Irrigation District

This exemption takes effect on 1 October 2019 and remains in force for a period of 5 years unless otherwise revoked.

Expressions used in this exemption have the same meaning as in the *Water Management Act 1999*.

PUBLIC NOTICE – SETTING OF TOTAL ALLOWABLE CATCH (TAC), DETERMINING THE PARTS AND PORTIONS FROM WHICH THE TAC IS TO BE TAKEN FOR THE COMMERCIAL SHELLFISH FISHERY.

Pursuant to the powers under Rule 7 of the *Fisheries (Shellfish) Rules 2017* ("the Rules") that were delegated to the Director (Marine Resources) on 12 November 2018 by the Minister acting pursuant to section 20(1) of the *Living Marine Resources Management Act 1995* ("the Act"), for the 2019/2020 quota period of the commercial shellfish fishery commencing 1 September 2019 and finishing 31 August 2020 inclusive, I hereby:

- (1) set the total allowable catch for the commercial shellfish fishery as: 4,900 kilograms of *Venerupis* clams; 0 kilograms of *Katelysia* cockles; and 21,400 dozen native oysters;
- (2) determine that the parts of the commercial shellfish fishery from which the total allowable catch is to be taken are: Georges Bay North Clam Zone; Ansons Bay Cockle Zone; and Georges Bay;
- (3) determine that the portion of total allowable catch to be taken from each part of the commercial shellfish fishery is as follows:
 - Georges Bay North Clam Zone 4,900 kilograms of *Venerupis* clams;
 - Ansons Bay Cockle Zone 0 kilograms of Katelysia cockles; and,
 - Georges Bay 21,400 dozen native Angasi oysters.

Rule 12 of the Fisheries (Commercial Dive) Rules 2011

Pursuant to the powers under the *Fisheries (Commercial Dive) Rules 2011* ("the Rules") that were delegated to the Director (Marine Resources) on 12 November 2018 by the Minister, acting pursuant to section 20(1) of the *Living Marine Resources Management Act 1995* ("the Act"), under Rule 12 of the Rules:

(1) I determine that the dates of closing of the commercial dive fishery in State water of Georges Bay to the activities of the take of Heliocidaris Erythrogramma sea urchins by the holder of a fishing licence (commercial dive) are as follows:

from 1 September 2019 to 30 September 2019 inclusive; and,

(2) I also determine that, for the period specified in this notice, if the holder of a fishing licence (commercial dive) on a fishing trip takes *Heliocidaris erythrogramma* sea urchins in the commercial dive fishery in State waters outside the area specified in this notice, then the commercial dive fishery in the area specified in this notice is closed to the holder of the fishing licence (commercial dive) to the activities of entering the water by swimming or diving;

where, Georges Bay is defined as State waters enclosed by an imaginary line commencing at Grants Point then following the line of high water around Georges Bay to St Helens Point then running straight to the point of commencement.

Definition of the parts of the Commercial Dive Fishery and the portion of the maximum live weight of a controlled fish that can be taken from the parts of the Commercial Dive Fishery

I, Ian Dutton, Director (Marine Resources), acting under Rule 14 of the Fisheries (Commercial Dive Rules) 2011 and delegated authority under Section 20(1) of the Living Marine Resources Management Act 1995, hereby determine that:

- the maximum live weight of Periwinkles (molluscs of the *Genus Turbo*) which may be taken in the period from 1 September in any year to 31 August in the following year from the Commercial Dive Fishery is 61.8 tonnes;
- the parts of the Commercial Dive Fishery from which the maximum live weight of Periwinkles may be taken are:
 - (1) **South Eastern Periwinkles Part of the Fishery** being that area of State waters on the east coast of Tasmania bounded to the north by an imaginary line running east to west from a point at lat 42°49'05"S long 148°00'00"E to the high-tide mark in the east at Munroe Bight and bound in the east by an imaginary line running south from a point at lat 42°49'05"S long 148°00'00"E and bound in the west by an imaginary line running north to south from Whale Head at a point at Lat 43°38'17.6"S long 146°52'15"E (From Whale Head in the south up the east coast of Tasmania to Munroe Bight);
 - (2) Central Eastern Periwinkles Part of the Fishery being that area of State waters on the east coast of Tasmania bounded in the south by an imaginary line running east to west from a point at lat 42°49'05"S long 148°00'00"E to the high-tide mark in the east at Munroe Bight and bound in the west by an imaginary line running south from a point at lat 42°49'05"S long 148°00'00"E and bound in the north by an imaginary line running east to west from Isaacs Point at Friendly Beaches at a point at lat 41°59'29"S long 148°17'13" (From Munroe Bight in the south north to Isaacs Point at Friendly Beaches);
 - (3) North Eastern Periwinkles Part of the Fishery being that area of State waters on the east and north coasts of Tasmania bounded in the south by an imaginary line running east to west from Isaacs Point at Friendly Beaches at a point at lat 41°59'29"S long 148°17'13" and bound to the north by an imaginary line running west to east from a point at lat 40°35'37"S long 147°46'28" and bound in the west by an imaginary line running south to north from the eastern end of Tomahawk Beach at a point at lat 40°52'29"S long 147°46'28"S until it intercepts with an imaginary line running west to east from a point lat 40°52'29"S long 147°46'28"S (From Isaacs Point at Friendly Beaches north moving anti-clockwise to the eastern end of Tomahawk Beach);
 - (4) **Northern Periwinkles Part of the Fishery** being that area of State waters on the norther coast of Tasmania and including the Kent group of islands, the Furneaux group of islands and King Island bound to the east by an imaginary line running south to north from the eastern end of Tomahawk Beach at a point at lat 40°52'29"S long 147°46'28"S until it intercepts with an imaginary line running west to east from a point lat 40°52'29"S long 147°46'28"S and bound to the south by the high tide mark on the northern coast of Tasmania until it reaches an imaginary line running east to west from a point at Cape Grim lat 40°40'40"S long 144°41'11"E which then serves as the southern boundary (Eastern end of Tomahawk Beach moving west to Cape Grim and including the King Island, the Furneaux Group and the Kent Group of Islands);
 - (5) **Western Periwinkles Part of the Fishery** being that area of State waters on the west coast of Tasmania bounded on the north by an imaginary line running east to west from a point at Cape Grim lat 40°40'40"S long 144°41'11"E and bound to the east by an imaginary line running north to south from Whale Head at a point at Lat 43°38'17.6"S long 146°52'15"E (Cape Grim south to Whale Head);
- the maximum live weight of Periwinkles which may be taken from each part of the Commercial Dive Fishery is:
 - I. Central-eastern Periwinkles Part of the Fishery 5.6 tonnes;
 - II. South Eastern Periwinkles Part of the Fishery 10.0 tonnes;
 - III. North-eastern Periwinkles Part of the Fishery 19.2 tonnes;
 - IV. Northern Periwinkles Part of the Fishery 13.4 tonnes; and,
 - V. Western Periwinkles Part of the Fishery 13.6 tonnes.
- the maximum live weight of *Heliocidaris erythrogramma* sea urchins which may be taken in the period from 1 September in any year to 31 August in the following year from the Commercial Dive Fishery is 175.0 tonnes;
- the parts of the Commercial Dive Fishery from which the maximum live weight of *Heliocidaris erythrogramma* sea urchins may be taken are:

- (3) **North Eastern** *Heliocidaris erythrogramma* **Part of the Fishery** being that area of State waters on the east and north coasts of Tasmania bounded in the south by an imaginary line running east to west from Isaacs Point at Friendly Beaches at a point at lat 41°59'29"S long 148°17'13"and bound to the north by an imaginary line running west to east from a point at lat 40°35'37"S long 147°46'28" and bound in the west by an imaginary line running south to north from the eastern end of Tomahawk Beach at a point at lat 40°52'29"S long 147°46'28"S until it intercepts with an imaginary line running west to east from a point lat 40°52'29"S long 147°46'28"S (From Isaacs Point at Friendly Beaches north moving anti-clockwise to the eastern end of Tomahawk Beach);
- (4) Northern Heliocidaris erythrogramma Part of the Fishery being that area of State waters on the norther coast of Tasmania and including the Kent group of islands, the Furneaux group of islands and King Island bound to the east by an imaginary line running south to north from the eastern end of Tomahawk Beach at a point at lat 40°52'29"S long 147°46'28"S until it intercepts with an imaginary line running west to east from a point lat 40°52'29"S long 147°46'28"S and bound to the south by the high tide mark on the northern coast of Tasmania until it reaches an imaginary line running east to west from a point at Cape Grim lat 40°40'40"S long 144°41'11"E which then serves as the southern boundary (Eastern end of Tomahawk Beach moving west to Cape Grim and including the King Island, the Furneaux Group and the Kent Group of Islands);
- (5) **Western Heliocidaris erythrogramma Part of the Fishery** being that area of State waters on the west coast of Tasmania bounded on the north by an imaginary line running east to west from a point at Cape Grim lat 40°40'40"S long 144°41'11"E and bound to the east by an imaginary line running north to south from Whale Head at a point at Lat 43°38'17.6"S long 146°52'15"E (Cape Grim south to Whale Head);
- the maximum live weight of Heliocidaris erythrogramma which may be taken from each part of the Commercial Dive Fishery is:
 - I. Central-eastern Heliocidaris erythrogramma Part of the Fishery 45.0 tonnes;
 - II. South Eastern Heliocidaris erythrogramma Part of the Fishery 44.0 tonnes;
 - III. North-eastern Heliocidaris erythrogramma Part of the Fishery 37.0 tonnes;
 - IV. Northern Heliocidaris erythrogramma Part of the Fishery 39.0 tonnes; and,

Public Notice - Determination of Minimum Size Limits Applying for the Commercial Dive Fishery

I, Ian Dutton, Director (Marine Resources), acting pursuant to Rule 13 of the Fisheries (Commercial Dive Rules) 2011, and delegated authority under Section 20(1) of the Living Marine Resources Management Act 1995 hereby:

- (1) determine that the minimum size limit for the species *Heliocidaris erythrogramma* is 70 mm;
- (2) determine that the minimum size limit for molluses of the Genus *Turbo* is 45 mm;

where the size of *Heliocidaris erythrogramma* is measured as the maximum diameter of the test (inside spines) of an individual *Heliocidaris erythrogramma*; and,

where the size of molluscs of the Genus Turbo is measured as the maximum shell width of an individual mollusc.
