FOREST PRACTICES AUTHORITY - NOTIFICATION OF INTENTION TO AMEND THE FOREST PRACTICES CODE

Please note that this advertisement will appear in Tasmania's major newspapers on Saturday, July 20 2019.

Pursuant to section 32 of the Forest Practices Act 1985 (the Act) the Forest Practices Authority intends to amend the Forest Practices Code 2015 (the Code) as follows:

- 1. replace the Guiding Policy with a Preamble and an expanded introduction (section A), and distribute commitments made in the Guiding Policy elsewhere in the Code;
- 2. clarify the scope and applicability of the Code to allow for its application where a Forest Practices Plan (FPP) is required, whether or not a FPP has been certified;
- 3. make numerous technical updates to remove uncertainty and bring the Code up to date with contemporary practices and technology;
- 4. include an interpretation and explanation of "forest practices" in line with the interpretation in the Act;
- 5. include a mandatory statement to be placed in all FPPs that references the Code and thus clearly links the Code to an enforceable instrument (the FPP);
- 6. add the requirement for a map to be included in a FPP and describe the standard of map expected;
- 7. refer readers to other applicable legislation such as that covering fire management, quarries, pesticide application or noise, without their re-iteration;
- 8. add an expanded section describing native forest silvicultural systems and native forest stocking standards, instead of referencing third party Technical Bulletins;
- 9. include stand-alone sections on the treatment of riparian zones in predominantly agricultural landscapes;
- 10. include a section on Stand Management that covers routine, low-impact stand maintenance activities that do not require an FPP.

The amendments to the Code proposed to be made by the FPA are set forth in a document kept at the offices of the FPA at 30 Patrick Street, Hobart, and at the Launceston and Burnie offices of Private Forests Tasmania and may be inspected by any person without payment of a fee from Monday, July 22 2019. The document is also available from the web site – www.fpa.tas.gov.au.

The FPA welcomes comments in writing from interested parties on the proposed amendment by the due date. Each line in the document is numbered, and comments should make reference to the line number(s) to which the comment relates. Further information about the process is available at – www.fpa.tas.gov.au.

Any person who wishes to object to the amendment of the Code may lodge an objection in writing to the amendments intended to be made by the FPA. An objection must specify the grounds of the objection and be lodged with the FPA by the due date.
