RULES PUBLICATION ACT 1953

NOTICE OF THE MAKING OF STATUTORY RULES

IN ACCORDANCE with the provisions of the *Rules Publication Act 1953*, notice is given of the making of the following statutory rules:—

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Administrative Arrangements Order 2019*

This order –

- (a) assigns to Ministers of the Crown the administration of Government departments, parts of departments and State authorities and Acts, or parts of Acts or subject matter of Acts, and other instruments of a legislative character; and
- (b) specifies which Government department, part of department or State authority is responsible to a Minister in relation to the administration of those Acts or parts of Acts or that subject matter and other instruments; and
- (c) revokes the *Administrative Arrangements Order 2018*, the *Administrative Arrangements Amendment Order 2018* and the *Administrative Arrangements Amendment Order (No. 2) 2018*.

(2) *Heavy Vehicle National Law (Tasmania) Amendment Regulations 2019*

These regulations amend the *Heavy Vehicle National Law (Tasmania) Regulations 2014* by –

- (a) omitting certain provisions that are no longer required; and
- (b) updating the schedule of infringement notice offences consequent on certain changes made to the *Heavy Vehicle National Law (Tasmania)*.

(3) *Fluoridation Regulations 2019*

These regulations –

- (a) prescribe for the purposes of the *Fluoridation Act 1968* –
 - (i) the acceptable concentration range for fluoride within a public drinking water supply; and
 - (ii) the record-keeping, analysis and testing requirements for water supply authorities; and
- (b) are made consequent on the repeal of the *Fluoridation (Interim) Regulations 2009* under section 11 of the *Subordinate Legislation Act 1992*.
