### GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Road Amendment (Personal Mobility Devices) Rules 2021*

These rules amend the *Road Rules 2019* by regulating the use of personal mobility devices on certain roads.

(2) *Vehicle and Traffic (Driver Licensing and Vehicle Registration) Amendment (Personal Mobility Devices) Regulations 2021*

These regulations amend the *Vehicle and Traffic (Driver Licensing and Vehicle Registration) Regulations 2021* so that personal mobility devices do not fall within the definition of motor vehicle in section 3 of the *Vehicle and Traffic Act 1999*.

(3) *Traffic (Compliance and Enforcement) Amendment (Personal Mobility Devices) Regulations 2021*

These regulations amend the *Traffic (Compliance and Enforcement) Regulations 2017* by prescribing certain offences under the *Road Rules* that relate to personal mobility devices.
