NOTICE OF THE MAKING OF STATUTORY RULES

In accordance with the provisions of the *Rules Publication Act 1953*, notice is given of the making of the following statutory rules:-

GENERAL PURPORT OR EFFECT OF THE ABOVEMENTIONED STATUTORY RULES

(1) *Health Service Establishments Regulations 2021*

These regulations –

(a) provide for –

- (i) the licensing of private hospitals and day-procedure centres under the *Health Service Establishments Act 2006*; and
- (ii) the disclosure by practitioners of pecuniary interests in such establishments; and
- (iii) standards for the day-to-day operation and management of such establishments by reference to the class of establishment and specialised services provided; and

(b) are made consequentially on the repeal of the *Health Service Establishments Regulations 2011* under section 11 of the *Subordinate Legislation Act 1992*.

(2) *Australian Consumer Law (Tasmania) Infringement Regulations 2021*

These regulations –

- (a) prescribe, for the purposes of the *Australian Consumer Law (Tasmania) Act 2010*, certain offences as infringement notice offences and the penalties payable under an infringement notice in respect of those offences; and
- (b) replace the *Australian Consumer Law (Tasmania) Infringement Regulations 2011*.
